The investigation is active and ongoing. There are no new updates to report.

Tacoma, WA. April 15, 2021:

On April 15, 2021, at 1:45 p.m., Pierce County Sheriff's deputies were dispatched to a report of domestic violence involving a weapon at a residence in the 14900 block of 272nd Ave. E. Deputies contacted the suspect who was armed with a handgun. An officer involved shooting occurred, and the deputies immediately started life-saving measures. The suspect, a 70-year-old male, was airlifted to the hospital and is in stable but critical condition.

No deputies were injured in this incident.

The Pierce County Force Investigation Team, comprised of members of multiple law enforcement agencies within Pierce County, was called to the scene for the independent investigation. The Pierce County Prosecutor's Office was advised of the incident and a member of their investigative staff responded to the scene to assist in the investigation.

The involved deputy has been placed on administrative leave in accordance with their department policies.

This investigation is ongoing.
