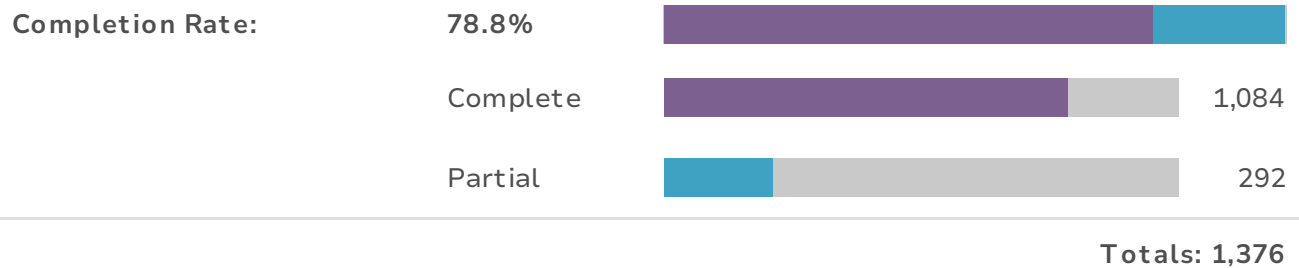
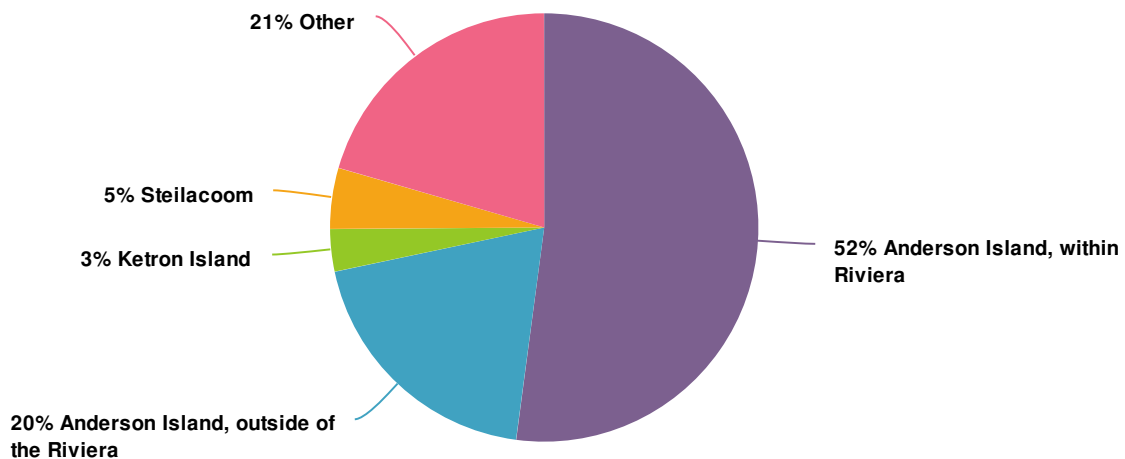







Pierce County Council District 6 ferry survey all responses

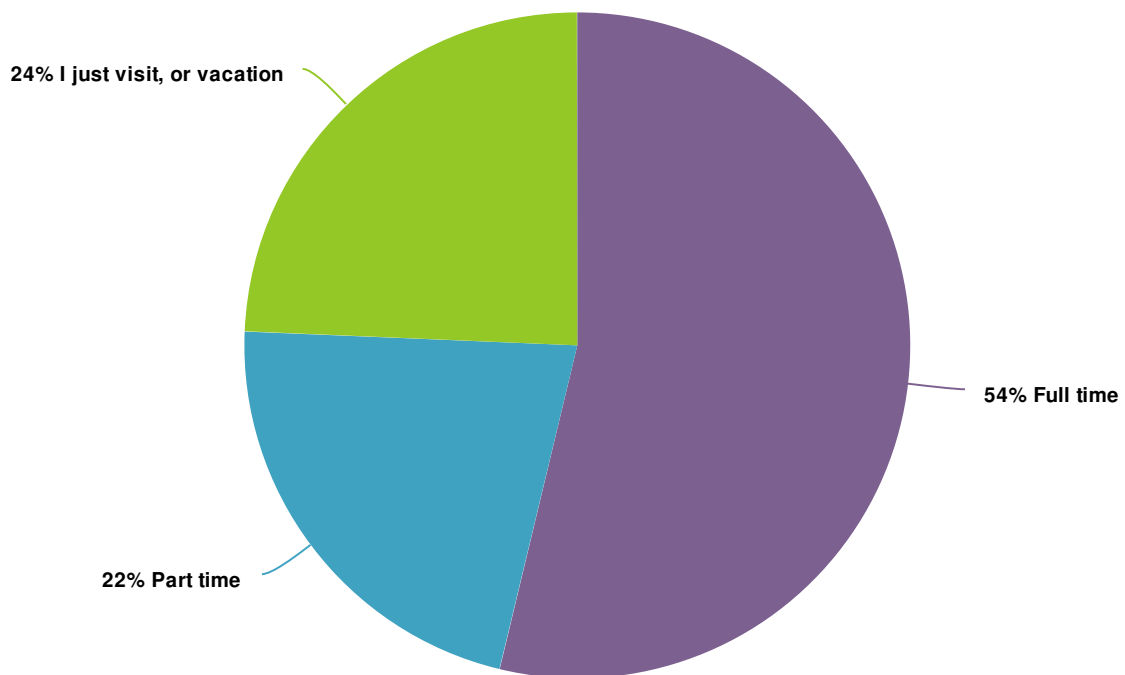





1. Where do you live?



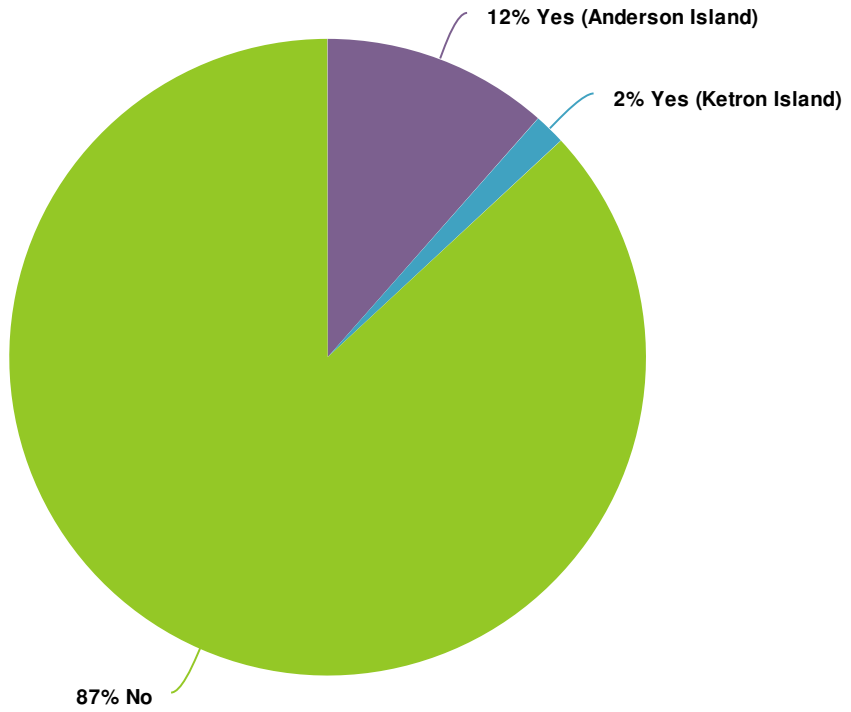

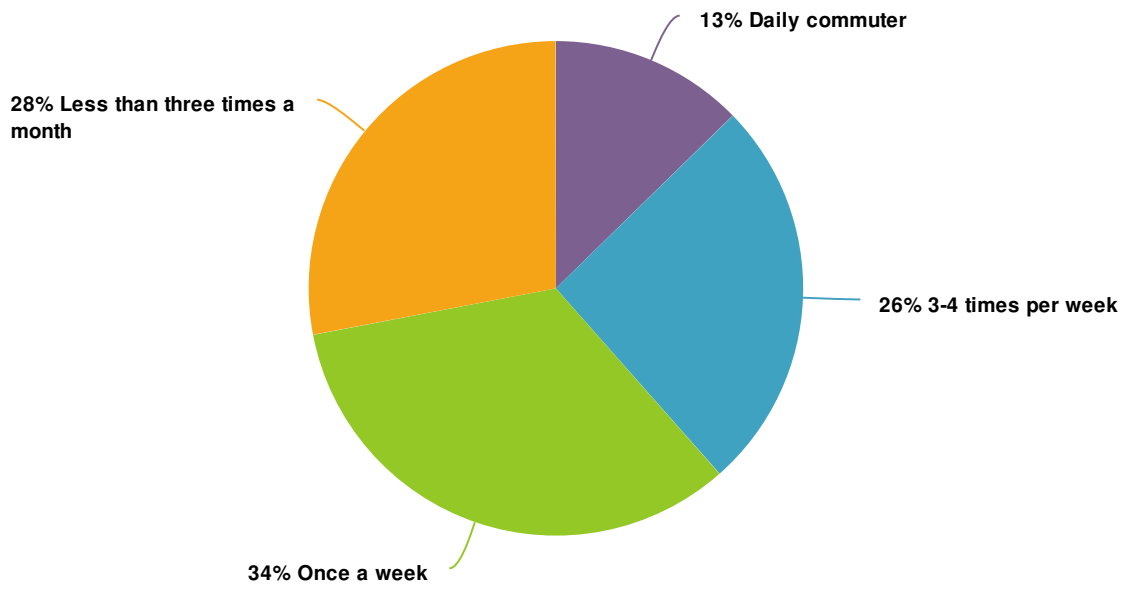

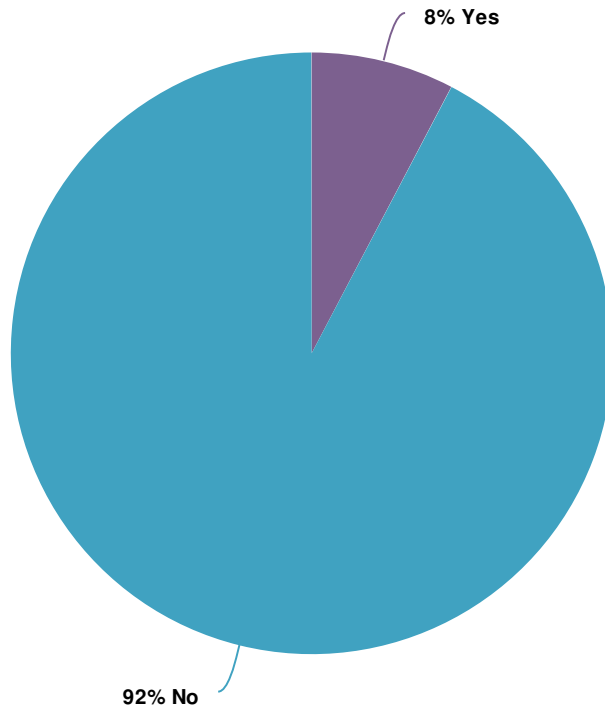

4. How often do you use the Pierce County ferry?



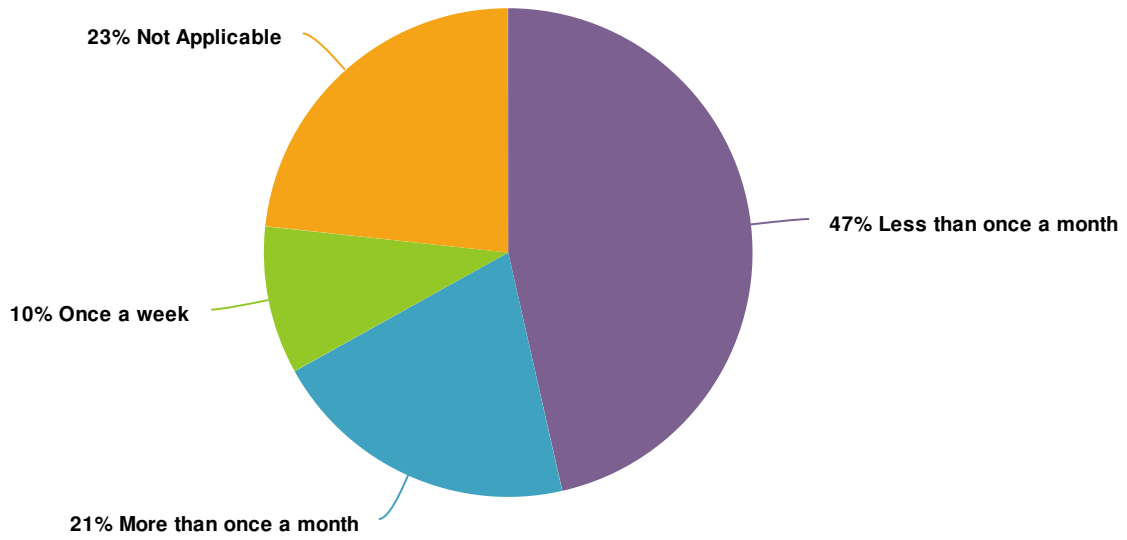

5. Do you have school-aged children that ride the ferry for school?



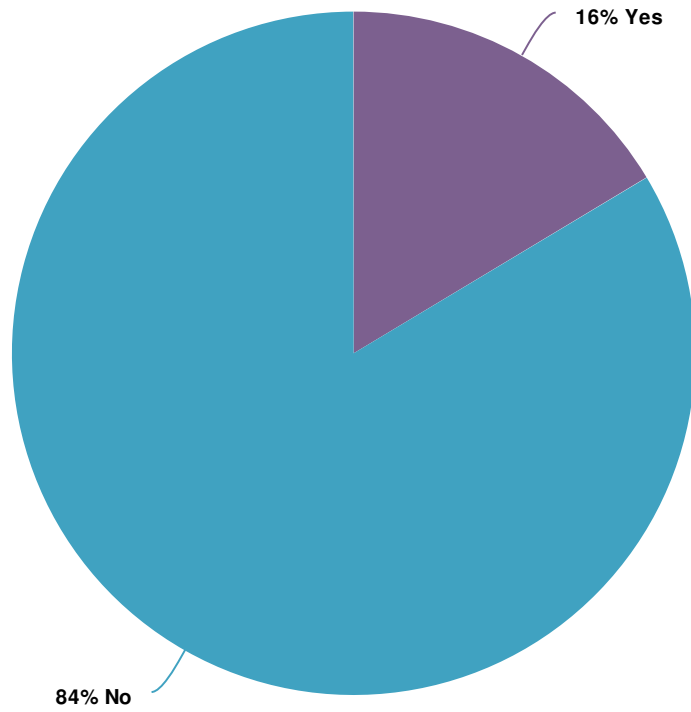

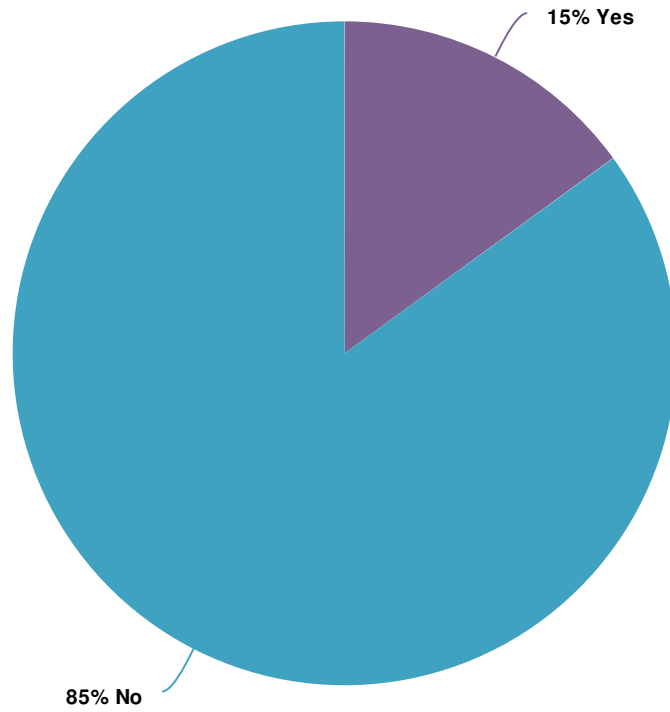

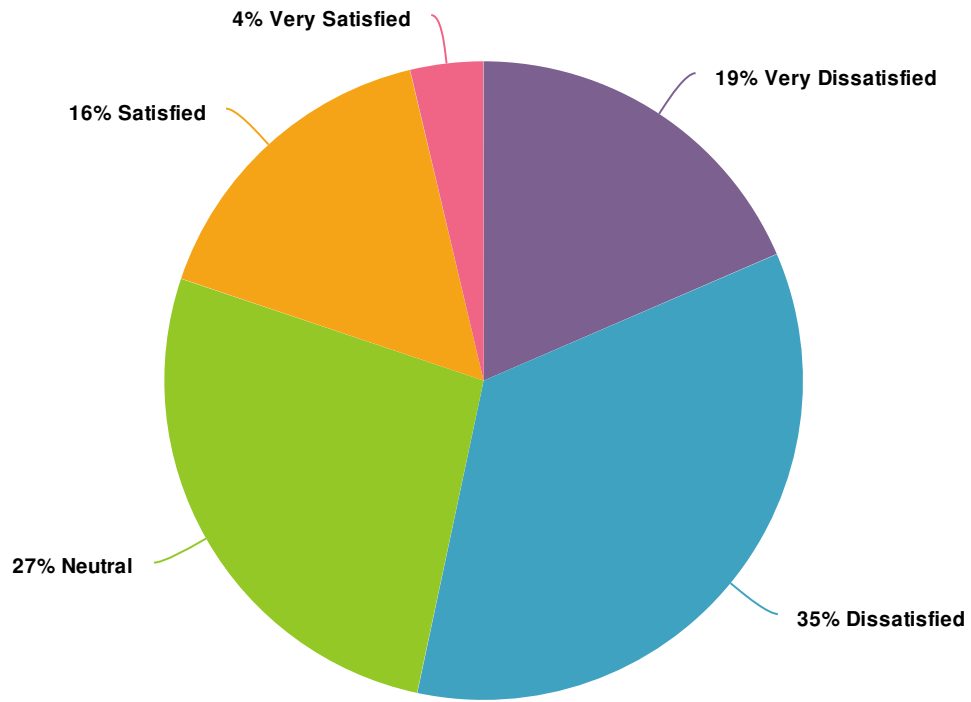

Response

A There have been a lot of improvements and increases in efficiency since I started to use the ferry 10 years ago.

A I is location of vacation home used only by myself and my two adult daughters with friends. We travel from the Greater Seattle area and have learned how to adapt and travel at lower traffic times (freeway & ferry). We have made it work for 20 years and LOVE Island time getaways! I have been involved in island events and an organization and have many friends who are residents. Thank you for caring about those who depend on the ferry with less flexibility. I do believe Membership in Northwest Airlift should be advertised and exposed much more than it is! It is very inexpensive Peace of Mind!

A direct ferry arriving in Steilacoom around 730 would be perfect. We must take the 620 in order to get to school on time and the stop at Ketron makes for a very early morning.

A direct ferry to Ketron around 3pm and 7 pm

A ferry between the 12:45 and 3:15 leaving island. More ferry runs utilizing 2 boat service during peak times which is becoming all the time now.

A shorter gap between the ferry closest to noon and the next available ferry would work best for us. We try to catch a later ferry to help lessen the earlier loads, but we don't want to wait until so late in the day.

Actually having 2 ferrys on the weekends

Adding back late afternoon and evening ferries. There are too many gaps now. Also, don't cancel double boat days during the only time we get them.

Adding extra ferries when needed

Appreciate the late night service during the weekdays.

Arriving as the last ferry is leaving and hoping to make the next one. I've been on a waiting list for my dental hygienist since January. They have called with last minute openings from cancellations numerous times, but there is no way to get on the ferry 'last minute' in most cases. We pick up guests on the Steilacoom side with our own boat, or have them walk on the ferry.

As a daily commuter, I would like to see a schedule better aligned with work hours. Also would be great to increase runs at times that are likely to be full.

As a senior I appreciate the senior fare discount. As an occasional cyclist I like the ability to get any ferry irrespective of wait lines.

As far as I can tell the system works pretty well other than the following two issues.

At this point with nearly every ferry run overloaded absolutely nothing works! The hideous ferry conditions are the only reason I am considering leaving the island for good! One can be an hour and a half ahead of boarding times and possibly still not get on the ferry! So One of the challenges is so much construction happening on the island. This has led to an unbelievable number of construction trucks on the ferry. The trucks not only take up several spaces for cars but in addition add extra weight that can leave room for more cars to board but they cannot board more cars due to the ferry being overweight with trucks! NOW of all things, there is construction beginning at the beginning of the ferry line on the mainland that is projected to last 90+ days in a summer that is ALWAYS busy and now even more so with so many new AI residents and air B&b's! Thank you so very much for any assistance you can offer.

Availability when I need it, sometimes.

Because we monitor ferry lines, we can usually avoid overflows. We also plan our time on the island on non-holiday weekends our outside normal surge times. My husband grew up on the island and we would eventually like to build a home there but are nervous about daily commuting.

Response

Before Memorial Day the service was almost adequate; I was the third car left behind once, but it was my own fault. However, I still have to leave home earlier than I would like in order to make the ferry.

Being Patient!

Being able to get to the mainland if the ferry is not broken down as long as there are not mechanical problems or staffing issues.

First, we used the ferry about twice a week most weeks and 3-4 in other weeks (your question above does not capture all possibilities well). We like the early ferries because we can leave the island early and do many errands on a day. We also like the late (10:20pm) ferry because it gives us flexibility to go out of the island and not have to fight I5 traffic in our way back to the island. I have missed the last ferry due to being stuck in traffic before.

For my use, the ferry service is fine.

For the most part the ferry runs on time.

For us the current schedule is fine.

For years the ferry left on the hour and half hour. Why did the change? Why have less ferry runs? Why are ferry back ups so bad during holiday weekends? If there are more people going to the island, then why not have two ferries running? Why is summer run schedule for only July and August? Most people consider June a summer month. You should publish ferry usage by month/week.

Frankly, I use the ferry service minimally. Usually when we're exploring the area, so only two or three times a year.

For an elderly person it is extremely stressful and trying to schedule medical appointments is becoming more and more difficult and putting off care that should be done because of the wait times going and returning. Having the early morning shifts is key to work schedules, so that really must be a daily thing. Sometimes it's not run at the 5:15 off island and that interferes with work. Having a holiday change the times (esp the summer) makes it difficult to keep work times required. We don't all have federal holidays off. Also, love the option to have a 10:20 ferry to return to the island at night- this helps with needing to leave after work day hours so things you need to do can get done without rush to make the 8:35 ferry.

Having the extra late run (10:50) has made it easier for me and my work schedule, having two boats on weekends...should be all holiday weekend Friday-Sunday in my opinion.

Having the ferry on time. Consistent loading. Clear signage regarding in line waiting for the ferry, (No engines running, no cutting in line, no leaving spaces, and ticketing information needs to be at the end of the ferry line on the Steilacoom side regarding tickets needing to be purchased at the dock.) Consideration of alternative transport methods for large construction trucks.

Having the ferry service run later would make this service work

Having the later ferry has been a wonderful change. The biggest problem is. Full time residents need to be able to get home to their loved ones after work. That is can be impossible especially during summer with so many visitors. There needs to be a pass or something that gives full time residents a priority loading. I am a nurse that has worked through the pandemic, I have to be able to get back home to my kids and father with dementia. The lines sometimes adds 3 additional hours to my day. Other islands have established similar set ups.

Having two boats during busy weekends

Honestly, very little works well. AICAB is horrible, the roundabout is a complete waste of TIF funds. My well documented emails to the Steilacoom town council were basically ignored. You could ask for improvement ideals...but leave Dave Albertson out of it. He is the worst... just pandering to special interest groups without actually representing us!

Maybe residents and guests. Having to wait in line an hour before departure/arrival is not always a convenient means. Just a thought.

Response

How well the crews work! Bathrooms are always clean.

I always plan to use the ferry when it's not a peak time. I also usually arrive both at Anderson and Steilacoom about an hour early to make sure I get on. I've been a ferry goer since I was a child and am now 81.

I am fortunate to have a flexible work schedule so I strategically plan trips to the main land and back to utilize underutilized ferry trips (not taking commuter ones). I personally like the 10:20pm last ferry from Steilacoom, it could be a little earlier as a last ferry, but this decreased stress of getting back to AI with the last schedule change.

I am in line 45 minutes early, and I still end up being in the third line and have to wait for an hour at least four of the next ferry. You need to have both fairies running full-time

I am looking at building in Ketron but the schedule won't allow for my commute.

I am now a remote worker so I don't use the ferry as much as I used to. What works best for me is the 10:00pm ferry since my religious meetings are on the mainland I will now be able to attend the meetings in person once we resume in person meetings.

I am on the 5:15am boat off Anderson Island and back home by the 5:00pm out of Steilacoom. More ferry services need to be offered Thursday and Friday's as well as Sundays.

I am retired, so the ferry schedule is not a real problem for me. The only time it's a challenge is when I'm trying to get home from visiting my family over the weekend. For the most part, I feel the ferry workers and the Pierce County Ferry Service is doing a very good job.

I am satisfied with the current operation of the ferry.

I am taking the 6:20 ferry off the island as there is usually not an overload. I return on the 10:35am ferry, so I avoid the busy afternoon ferries.

I appreciate that the Ketron mid day run is at the 11:10 run. I think that is the best option, I would not want it to change to 10:05 or 12:45. I appreciate the late night runs, so I can enjoy mainland life as well.

I appreciate the 10PM ferry. I appreciate double boat service in the summer.

I do not use the ferry's. Too expensive

I don't ride the ferry. I live in Lakewood

I don't use the ferry

I eventually arrive at the island.

I eventually arrived at the island... that's the only part about the entire experience that works.

I find most of the times that I use the ferry system everything works well. The one large concern that I have is people that leave their cars running the entire time they are waiting in the ferry line. They exhaust can be very nauseating and horribly unhealthy for those parked near them.

I find the ferry schedule to be mostly adequate for my needs.

I generally satisfied so I would say that most of the service works.

I get there but it is a huge hassle & headache rat race. HURRY UP AND WAIT! is the feeling. Get in line an hour earlier so now my commute is close to 3 hours one way to Fife. The ferry service sucks and is overwhelmed. We need service that can keep up with the demand!

I have no idea

I have used this ferry once in 30 years.

I just enjoy visiting so I am fine with our ferry service and love being near the water and ferries!

I kept my motorcycle to be able to get on and off quickly. I'm disappointed in the frequency of the ferry on high traffic days.

Response

I know it may be cost prohibitive but, AI is a totally different animal than 3-4 years ago. Ferry ridership seems to have tripled. And the ferry system doesn't seem to have adjusted. More attention to peak ferry volumes And better use of both vessels.

I know that the ferry employees are doing the best that they can I can't blame them for situations that happen unexpectedly. Probably my only complaint I have is the "better than thou Attitude" that some of the workers have!

I like a consistent schedule with few problems. I have not experienced as many problems using Washington State ferries. I rely on our ferry for doctor, dentist and other appointments. When it runs late I will be billed for a missed appointment. We are on a fixed income so this is not acceptable.

I like being able to purchase ticket online. I love having a worker monitoring the line and scanning the tickets.

I like being able to purchase tickets online and that the tickets are scanned when you are already in line.

I like having a very early and late ferries But not having a gap in service midday

I like having access to the ferry, however I wish there were more consecutive runs

I like having regular times, staff is always nice

I like that a late run has been added. I feel less stressed about going places, and getting back before the last run.

I like that the schedule is such that there are fewer delays as the old schedule had. 1 hour 10 minutes per run is just about right for loading and unloading.

I like that there are early ferries and ones that run late.

I like the ability to buy tickets online. I like the later hours

I like the crew

I like the early and late runs. Thanks for those.

I like the ferry times overall. The staff is nice.

I like the later ferry. Maybe 10pm would be better but i will tske what i can get. I need this later run on Thursday nights.

I like the later times, I think the staff are friendly and professional. The reliability is what I would predict based on what we pay in fare

I like the purchasing of tickets on line and using your phone to show purchase.

Response

I like the sections when the ferry runs every 60-70 minutes. Friendly staff Clean ferry Load and unload is smooth

I live in DuPont and am retired so I do not use the Ferry for work or daily travel. I do use the ferry for vacation.

I love and appreciate the ferry service. While my son was in high school on the mainland, he endured the (then) poor timing for the bus - but I see that it's improved somewhat for future students. That's good news. I also appreciate the later runs at night.

I love everything about the ferry except...

I love that we have regular ferry service. We also don't require many trips to town as we make the once a week trip a very productive one by getting a lot of errands done to keep from having to go into town more frequently and to save ferry fees. It would be nice if there wasn't a break in the ferry schedule between 12-2:45.

I love the online ticket app. I'm not a commuter anymore but I appreciate the schedule changes that slowed the ferry to leave on time more often than it used to.

I miss the direct run to Ketron and back. Plus another daily trip to Ketron is needed. No runs between 10:30 and 7:30 does not seem fair.

I moved out here full time in 1990 so I know about limitations. I now go 1 hour ahead of needed ferries and within the last 2 months have read 37 books while waiting.

I must go on a very early ferry (6:20) just to get off the island without waiting 2 hours in the car in the ferry line. I must plan my return to the island after 6:00 PM in order to not wait for 2 hours in the ferry line in Steilacoom. It is inexcusable to need to do this, and live within these constraints.

I never use it and don't want to pay for it. Let the people who actually use it and benefit from it, pay for it. Also, you don't have an option to say this doesn't apply or never. Poorly constructed survey.

I never use it.

I only use the ferry about once a year for a visit to Anderson Island.

I rarely use the Ferry

I rarely use the ferry.

I really appreciate the two boat service on Fridays and Sundays in the summer. The app for ticket purchases works well Appreciate the text alerts

I really love the days 2 boats run. It makes it easy to do my grocery shopping. The staff are always friendly.

Response

I ride a motorcycle which helps with lines. The schedule is appropriate The ferry crew are awesome

I see lots of full size double cab trucks up to 23' long getting on for the same fare as a car. They use lots of space. Vehicles over 16' should pay a surcharge, that would encourage use of more sensible vehicles, and get more cars on the ferry which leaves cars behind on many runs. Vehicles 17 to 23 feet long should be a higher fare and have 5 pass ticket options.

I suppose the boats work some of the time. Besides that the ferry is full of issues.

I tend to travel late evenings and early mornings, because I have that possibility, to avoid long lines at the ferry.

I think a 110 ferry would work. I also would like to see where the ferry arrived like on the hour than the half hours so if you leave the half hours from Anderson Island you hit on the hour over on the other side it'd be easier to schedule doctor appointments if we could do that

I think the crew does a good job. The problem is lack of service and people blame the crew for COUNTY SCHEDULING.

I thought it was good when the later ferry was added last year. The after 10pm ferry, I mean.

I try to work around the high volume visitor schedule at this time...the island is definitely more populated...and many more visitors....the more ferries, the more people...let them sit in line, if they really need to go or come....

I use it for weekend recreational outings, and I use the schedule as available and plan around it so it works fine for me.

I used to committee from the island but moved off. It was too unreliable. Now if i go i try to avoid high traffic times. Or I walk on.

I usually make it to work on time when the ferry is running and nothing is broken down or not running properly.

I walk-on 99% of the time and watch with horror as the chaotic world of drive-ons deteriorates. However, the ferry runs, doesn't sink, and is cheap (for seniors). Most problems disappear with time as crew members quit and take their issues with them. If one keeps expectations low, the ferry will usually fulfill them in the winter...not so in the summer. You must change your use of the ferry in the summer to accommodate serious disruption and delay.

I work with the existing system well. I time my trips so I do get on, sometimes arriving > 1 hour early. When I do leave, I usually leave on the first and return on the last ferry. The ferry system works OK for me.

Response

I would much prefer wait periods no more than 90 min especially in summer when ferry traffic is heavier and temps are higher as I almost always need to bring food down with me esp meats, fruits, veg and Refrig items!

I'd like to see more weekend runs.

I'm a daily commuter and when the schedule changed I was very angry as I had to completely change my work schedule AGAIN., because the 6:20 ferry no longer got me to work by 7 due to the addition of the Ketron run. However, now, given the HUGE problem with overloads on ALL ferries, coming and going, during the week and weekend, day, night, and inbetween, I am GRATEFUL, for the addition of the Ketron run because I'm nearly ALWAYS guaranteed a trip. Why? Because NO ONE Wants to ride the commuter ferry that takes TWICE AS LONG as it did before. But, hey, I'm happy, at least I get a seat.

I'm appreciative we have a ferry.

I'm completing the survey in hopes of getting more ferry time to Ketron. My best friend lives on the island and I rarely get to see her family because of ferry limitations.

I'm grateful the ferry operates daily, however, I definitely feel that a 2-ferry system needs to be implemented. Daily.

I'm new to the island, I came for many reasons, needed a huge life change, finally figured out where I belong, but I still need to work on the "mainland, so. I'm happy to have this service, but it seems antiquated, and everyone here complains. However, that said, The ferries seem well maintained, generally clean, etc.

I'm not there often enough to say. I'm glad there are early runs for working people.

I'm only an occasional user (1-2 trips a month) so current schedule works for me. Since I am retired I can avoid travel during peak times.

I/we can work our schedule around the ferry schedule. It works for us.

IMO island living is not suitable for families with teenage children (lacking educational and social opportunities), daily work related or medical related commuting. And that is a given or should be known before moving to an island.

If I leave for the island on Saturday morning I can usually be sure to catch the boat and not be in an over load if I am down at the ferry 45 minutes before scheduled departure.

If I'm catching ferry during off-peak times it works. This isn't realistic for working professionals.

Response

If a ferry service for Ketron mid-afternoon and perhaps later in the evening was available, at least if requested ahead of time, that would be very helpful. Taking the ferry in the morning and not having service available until 7:20pm is incredibly inconvenient and inconsiderate given the amount of runs going to Anderson and the lack of private boating options on the island. Additionally, the recent cut by 25% does not support the community.

If they could be on schedule more often it would make for a less stressful trip when we are trying to make medical appointments we always have to go early so that we are not late do to ferry service

If we could get on mainland a little earlier the time the fairies leave Anderson Island isn't convenient for mainland doctor appointments which are usually on the hour and half hour when we get over there like at the last ferry at 12:50 and can't get back on to 2:45 and your doctor point music takes longer you know you're not getting home till 3:00 or 4:00 there have to be some way to get the ferry scheduled where it's over on the hour a half hour on the other side so you could schedule appointments better

It doesn't work for me, in the least. I would travel to Ketron, to inspect/service my properties, more often if it were more convenient. There are only three (3) daily runs to Ketron, but it takes 90 minutes to get there as all runs to Ketron go to Anderson Island first. Furthermore, by holding Ketron bound vehicles on the ferry, space for Anderson Is. vehicles bound for Steilacoom is reduced by the number of Ketron Is. vehicles still aboard. Whoever is responsible for approving the ferry schedule is not serving the public very well, and certainly not equitably.

Response

It doesn't. I have to plan way ahead and I still end up waiting hours on both sides. We need a bigger ferry, more runs or double boat service during peak hours.

It floats and gets us there...but It's easier to say what doesn't, which is waiting for an hour to catch a ferry to get to work. Not everyone here is retired or wealthy. It was actually a cheaper place to buy. More ferries, more times, especially seasonally and before and after holiday weekends, Thurs-Mon holiday weekends are necessary. As more have moved here and there seems to be no regulation from county on rentals here, people that *do* work are suffering the consequences. Herron is And has remarkable service far cheaper! Check it out for advice! We NEED HELP!

It helps when more than one ferry runs. I appreciate the cameras , that gives me a heads up when to leave for ferry. I appreciate announcements of ferry changes. The staff has always been friendly. I like the online ticking.

It is a shame that we must plan to be at the ferry at the time the ferry leaves in order to catch the next ferry, and all on purpose.

It is fine during none peak times/days

It is good to have two ferries running for weekends

It is imperative that two ferries run from at least Memorial Day week-end through Labor Day. The waits are terrible, there are way too many construction and RV vehicles that take up the space of several cars. There needs to be much more AVAILABLE overnight parking or monthly parking to more people can walk on. It is impossible to count on getting home and not getting stuck. there has to be a way to resolve this issues with either a bigger ferry for less personnel costs, but far more vehicle costs are just keep two ferries running during the peak months and days. You have the rider data to figure this out. Charge construction vehicles; have special runs for owners only or preference tickers, etc. This can be addressed in a logical, fair way!

It would be awesome to have a direct ferry to Ketron at 3:00 pm and 7:00 pm. The current schedule limits our ability to go to the island.

It would be nice to have two ferries from beginning of May till Labor Day. The Island is packed with people. Every ferry from 7:35 am till 7:20 is overloaded. The ferry schedule 12:45 pm till the next 3:15 pm is unbearable from the Island. The 12:10 to 2:45 pm is horrible schedule. I need to get in line by 1pm to make the 2:45 pm ferry from Steilacoom. We need another ferry schedule between those times. I spend 3 to 4 hrs on ferry lanes in a day to go for 45 minutes doctor or physical therapy appointments .

Not much works well at all! The weekday schedule is not set to keep people moving on & off island in a timely manner. The large gap in the middle of the day is counterproductive to getting people back on island and causes large backups once the commuters start coming home.

Not much works. You have to allow at least a hour minimum to be 75% sure that you'll get on. Usually have a hour long wait or longer if you don't get on the first run you want. Weekends are a horror show, holiday weekends are impossible no one seems to take in account that holiday weekends usually start on Thursday. Weekday mornings are awful you have to be there at least minimum a hour before. This is every weekday morning. Large trucks should be prohibited on these runs so the commuters have a chance to get to work on time. None of these things seem to be taken into account.

This desire to be always on time has overshadowed all other concerns and makes no sense. We need smaller gaps between boats and less 1:45 and 2:30 sized gaps.

Response

The way the current schedule is constructed it does not allow for much flexibility to the rider, especially if you are left behind because of over crowding. Because it cuts down on the amount of time you have to conduct your business on the mainland with the early night schedule. If the ferry ran on a consistent schedule, similar to the two boat ferry schedule, it would work better for everyone because it would ease the over crowding and not leave riders behind much of the time. In addition, the last run instead of 1020 pm should be around midnight to give more flexibility for riders in the evening. Those small changes would benefit the consumer greatly going forward because the population and popularity of Anderson Island has increased at an alarming pace over the last 4 years .

The online ticketing system with the phone app has been a great addition as well and generally works as it is supposed to.

Response

To be honest, very little. The ferry lines - even midweek - are terrible. The 2+ hour gap in the middle of the day requires being in line at least an hour before schedule, and still might not make it. It's honestly a crapshoot - even on what should be light days. Basically almost every morning ferry from Anderson, and almost every evening ferry from Steilacoom is an "overflow". The ferry crews do a good job of packing the cars in, however there are times when the ferry isn't fully loaded and leaves vehicles in line. Perhaps this is to get back on schedule. The number of outages for mishaps or scheduled maintenance has been bad. It would be nice to know the ferry revenue/cost to the county - for past 3-4 years and projected 5 years. Someone must be doing a this. Simply put, need to run both ferries, and have a backup plan.

Too long of break from 12:00 leaving town to the Island. I feel ferry should arrive back from Anderson Island at 12:55 and after a lunch break leave at no later than 2:15 daily. Also a must would be Memorial Day to Labor Day two ferries from 12:00 to 6:00 every Friday and 10:00 to 5:00 every Sunday unless a holiday then I would skip Sunday and move to the holiday and perhaps the day after the Holiday

Too crowded at peak commuter times. Thurs-Sunday. I'm a nurse. I've lost jobs over the schedule.

Too long of time around 10 to 2:30 between ferries....have to wait at least 1 ferry time to get on....more busy in summer. By the time we drive up from Vancouver, we usually have to wait 1-2 hours for ferry and usually miss one and then it is 2 hour wait.... Should survey when people actually use the ferry and cut out ferry with low ridership and add in ferry for when people are riding it.. And prevent waiting so long..... Walk on works as long as you have parking available to store a vehicle.

Walking on, the service is wonderful and reliable.

We are fortunate to be able to time our travel to/from the island on non-peak times, so our experiences are mostly positive. Operations are prompt, timely, and most employees are very courteous.

We are new to it. We just plan ahead.

We are new to the island so we're still adjusting to the system.

We do like that there are 2 ferry's run during the summer months.

We don't leave often because I work on the island. However, leaving and returning has become very challenging in the last three years. I would encourage Pierce County to become members of the Anderson Island Facebook page and monitor the daily/hourly issues and complaints from residents. It has become a nightmare for daily users.

We have a ferry

We have a ferry at all

We have not been stranded on the wrong side of the water in a few years, which is fundamentally the service being provided I guess. But it requires significant amounts of our time to make sure that's the case.

We have to show up an hour early or we don't get on. Always an overflow during peak times.

We have vacation property on Anderson Island for 20+ years, and have enjoyed the ferry system.

We like the ferry service when there is minimal waiting. We like the posting of ferry times.

Response

We like the new schedule. We like to come over early on Fridays and leave later on Sundays. We rarely have ever missed or had to wait for a boat.

We live on Anderson island about 90% of the time, didn't move out near-full time until we retired. Ferry workers are diligent in keeping the schedule and maximizing loads when necessary. We generally use the ferry at non-peak times. Living with a shared resource requires adjusting to accommodate for others and to limitations of that resource.

We lived on the island for a couple of years and on a daily basis things work well during the regular year.

We love our ferry and the crew. Long wait times often dissuade us from visiting our home there.

We love our friendly workers.

We love the late evening ferry.

We need 30 min ferry runs two ferrys from Jan to Oct

We need a bigger ferry!

We need a bigger ferry. And please pay our workers more.

We need a run at 1:30 to help with the gap between 12 and 3:15.

We need more ferries, or a bigger ferry, for a growing island. Simple as that. Too many people, and islanders can play the blame game all we want—people are moving here, building here, visiting here, and unless we are going to prevent others from moving or visiting, which is probably unconstitutional for all sorts of reasons, then we need to actually grow the ferry service along with the island, the region and the state. And we need you to lead that effort as our representative, or respectfully, we will find someone else who will.

We need more ferry runs daily. Then 2 boats Friday Saturday and Sunday. Thank you.

We need more ferry service in June!

We need more ferry service. Yesterday (Thursday) we waited 3 FERRIES TO GET OFF ISLAND -in 14 years of ownership, this was a first. Many people confused by the process of pulling over into the first lane when the boat is full. No one to oversee process and lots of angry people. Arrived at Steilacoom dock @ 4:45 pm to go back to island and finally made the 7:10 Ferry. This morning I opened up VRBO and AirBNB-and quickly noticed how many houses that have recently sold on the island were short term rental investments. Often 2 bedrooms and sleep 8 people...So many people riding the ferry now are short term renters. Additionally, so many new housing starts mean lots and lots of service and construction vehicles on ferry runs. Changes just follow this new island growth.

We need more runs

We plan our trips during off-peak times when possible. The AI app showing cameras is a great help to know when to leave so you get into at least lane 2.

We recently purchased our lot so I don't have much to add here

We travel at least once a week to Anderson Island and use the ferry cameras to see what ferry will work the best. The ferry and dock cameras are very helpful.

We typically head for the ferry line within 10 minutes after the departure from the island so we are assured a place in line.

We used to go to church at 9:30 Sunday morning in Olympia. With the change from 8:30 to 8:55 leaving AI we are no longer able to make it. This is the only inconvenience that we have had.

We used to have triangle runs that made it so at least twice a day there were direct ferries to and from Ketron; one in the morning and one around 5:30. Ketron can't get repairs or even basic maintenance done because of the ferry service. We had to uninstall put air conditioner and put it on a truck to the mainland for maintenance. I currently have a broken water heater that I have been trying for 6 months to have repaired. The schedule is less than half what it was 20 years ago.

We would like to visit Anderson Island more frequently but the concern of missing ferries is keeping us away during busier months.

Webcams are super handy. Nice using app for tickets.

Week days usually work fine.

Weekend and holiday double runs

Weekends are horrible for waiting for the ferry, so rarely make appts. then but I leave after morning rush and try to get back before evening rush-hour. If not, it's an hour or more (sometimes 2 1/2 hrs. to get on. So it's like 10 hrs a month waiting on line.

Well the ferry usually runs. What "works" is to leave very early in the day and try to get back for the noon return ferry before the big overflow traffic. It certainly limits my plans for mainland trips.

What a stupid question. It gets me back and forth.

Response

What doesn't work is having to be in line for the ferry an hour ahead of time because of overloads

What used to work was getting to the ferry line 30-45 minutes early. That doesn't seem to be the case anymore. Someone watching how the cars line up works, but there isn't really that going on either

What works is that you have to adapt. Things are constantly changing day to day, week to week. As a retiree, I have that option. I know the pitfalls and I work around the issues.

What works is when the county runs two ferry service to accommodate the number of passengers.

When 2 boats are running during busy times/weekends

When it runs HORRIBLE service to Ketron...

When the second boat is in service it is more reliable.

When they run two ferries on busy days

When two boats are running commute on the ferry runs more smoothly. Traffic on the ferry has increased in the last year significantly and one boat service does not work. Long wait times, 3rd lanes full often. Waiting for next boat after not getting on the current is a regular occurrence.

When you run two ferry's during the peak times

When you're able to get on the ferry the crew is extremely helpful and the ride is comfortable.

With a little extra time between runs they are more on time. Communication in regards to delays is a great help.

Response

With amount of construction on the island it would be beneficial to few extra runs during the spring and summer months. And to have the two ferry's running in the summer on weekends is very helpful but to have them cancelled last minute for staffing issues is really unacceptable. I know it's a very difficult juggling act to keep everyone happy and I appreciate the communication asking for feedback on current issues.

With my limited experience using the Pierce County ferry service, I can say that when I've used it, it seems well coordinated. I don't have an opinion about what works and what does not.

With the amount of people that now live all of the time on Anderson Island they should be running two ferries all of the time. The very first time I went to the island the ferry held nine cars in 1962 but in today's time the ferry system has not kept up with the growth on the island. I am not talking about holiday weekends but all of the time. I ask myself, what is my time worth? To me all of this is so sad with the ferry system not keeping up with the normal growth.

Knowing the crews need a break for lunch, just wonder sometimes if there isn't another way to provide this break without resulting in such a wide time gap in the schedule. This seems to generate a backlog that takes many ferry runs to diminish. Especially in The Summer.

Response

Living just past the ferry line on Lafayette at Union Streets, we are very upset that the new plans for the roundabout in Steilacoom and redesign of the ferry lines will cause a blockage of the end of our street at Union. This will be extremely inconvenient for us as we park in the front of our house and will have to turn the car around to exit the street as we don't have a driveway or garage that would help facilitate getting out. It will also reduce the time emergency vehicles will be able to get to our street, and parking for fire vehicles will be difficult. 6:20am run going to Ketron instead of straight to Steilacoom makes it difficult to get to work/appointments in Tacoma or Olympia by 7:30am. I'm a rare user of the last late ferry but wonder if we really need it seven days a week. Consistent overloads mean that to ensure one makes it onboard (drive on), one has to get in line 45-60 min prior to departure. Concerned about long-term capacity of island commuter parking lot and availability of commuter parking in Steilacoom. No effort by PC or TPCHD to reduce idling in ferry lines. Would like to see the county strategically address long-term demand for ferry services based on AI build-out models. Would like to see consideration of options for addressing ferry service demand, including conservation purchase of development rights or outright purchase.

A later ferry on the weekends A second ferry added May-Sept from Friday noon to Monday noon

A mid-day ferry stop at ketron would be great and a return of the Friday/Saturday late night ketron run seem essential especially if we are to see any growth to the island community

A permanent scheduled use of the second ferry. The population of Anderson Island has increased dramatically.

A possible extra run to/from Ketron on weekends. Would love to have an afternoon ferry pick up from Ketron on Sundays. Also, an afternoon from Stillicum Fridays and Saturdays. Increase the time on island of the service ferry run to ketron.

A reservation system may be helpful for especially busy holidays.

A schedule that could eliminate the consistent overloads

A setup similar to that for the Vashon Island ferry system, booth at the top of the line directing you to the appropriate lane. Priority loading for residents and commuters. For the sake of time, even the consideration of something similar to Good to Go with a tag on your vehicle for residents that would validate priority loading. Consistent interpretation of the loading rules, cutting, leaving vehicles, etc., amongst personnel and the sheriff. Also, it's ridiculous to expect people to stay in their vehicles for an hour or longer while waiting for the ferry. Signs and the ordinance and enforcement regarding cutting are inconsistent, people are told to fill the gaps but then are reported as cutting. It might be wise to eliminate the layover during mid-day, it causes nothing but more overloads from both directions every day leaving residents with no way to plan for appointments off Island. A way to book passage on a certain ferry in advance. More mid-day runs.

Ability to load the ferry better to accommodate more cars. There are constant overloads and even arriving an hour early does not guarantee that you will make it on the ferry. We need an extra run or 2.

Absolutely, we need more ferries or another solution for the overloads. The situation will not improve, but only worsen. Action is urgently need it.

Response

Accept the fact that the Island population is growing by leaps and bounds and make your schedule accordingly.

Accepting Apple wallet payments.

Accommodations for trailers and large vehicles could be better organized and published. Increased incentive for non-vehicle passenger use could be beneficial to alleviate capacity issues. High occupancy commuter benefits— carpoolers get better rates or an "HOV lane" Better anticipation for holiday overflow— or lower cost for earlier trips and raise cost of ferry during peak time. Better enforcement of lines— don't allow free entry into all lanes people have been going wherever they please lately.

Add 1:30pm ferry to avoid backlog

Add 2nd ferry during high use times for daily commuters as well as week- ends and holiday travel times.

Add a 5:15 a.m. sailing on Saturdays and Sundays

Add a mid day crossing and start the two boat holiday service in the morning. Look at the ferry lane cameras from this last weekend. Overload started at 9:00.

Add a passenger only ferry (the Riviera used to operate one when we purchased land in late 60's) There is a need for this type of service again.

Add a run from noon ferry and 3:15. Take the Ketron run away on commuting run.

Add another boat time between the 12:10 and 2:45 from Steilcoom. Get a bigger ferry.

Add another ferry between 12:10 to 2:45 pm

Add another mid-day ferry. The long wait to get home with groceries, or from medical appointments is very hard on all islanders and their pets, especially on these hot afternoons.

Add the 4th run back and a mid day one as well. Too limited for tax payer contributions, plus if Pierce Co. would like to see more tax base revenue from Ketron, they need to make it accessible or folks won't buy there, and there won't be more lucrative island tax base.

Adding a midday run is a must. The population on Anderson Island is exploding and the current schedule doesn't offer enough trips

Adding a run about 1:30 pm and deleting the last ferry run will help for the majority. AICAB ferry committee members have not been asked by PC for input. AICAB is considered only advisory by PC and islanders are feeling not being heard and attending meetings - what's the use..

Adding an early evening/late afternoon ketron run would be an improvement

Additional runs, two boat service Thursday-Monday. There is just too many people coming and going and making people sit in a ferry line for hours is a complete inconvenience. People will pay more for a consistent two ferry service. People should be able to arrive 20-30 minutes before the boat leaves and make it, not 2 hours early.

Adjust the double ferries to be more than one day before and after. Look at what happened this year. The overloads off the ferry affect working class folks who live here but work off island. Later ferry runs would help with people who work different shifts and after school sporting events.

Adjust the ferry schedule to align with mainland school schedules.

Adopt a permanent schedule only after doing an extensive and transparent survey of people that are actually lined up to ride every day in addition to the occasional riders. Like many other full time employed Islanders working on the mainland, I cannot make ferry meetings because they are not scheduled to accommodate most.

Afternoon ferries. Fill the noon gap so you are not starting with overloads and have to spend all afternoon catching up.

An additional mid-day ferry (say 1:10) would do a great deal to ease backups and over crowding later in the day. The ferry schedule and increasing backups make Dr appointments etc. very difficult for people.

An even later ferry Free or affordable parking in Steilacoom A shuttle to the lakewood train And lakewood bus center

Anderson island is growing so fast we almost need 2 boat services everyday. There are constantly overloads. That means people are late to work, appointments or missing events completely. Going to Anderson overloads means not being home when your kids get off of school or coming home with spoiled groceries. It's majorly affects our everyday lives and it should not be considered a miniscule inconvenience.

Another boat

Another ferry between 12:10 and 2:45.

Another ferry in the morning and afternoon like the previous schedule. The current schedule eliminated two (2) ferries during this period.

Another ferry in the noon break time would help.

Another ferry midday would be great to avoid that long hiatus and subsequent overflow in the afternoon.

Another ferry run in the middle of the day, the long gap between 12:10 and 2:45 is too long, that always seem like the time I would like to head home and both ferries are always overloaded because of the long gap

Another ferry to Ketron

Another ferry? Schedule big loads better? We don't go over much anymore because of the long ferry waits.

Another run between the 12:10 PM and the 2:45 PM ferry to avoid the daily overload on the Steilacoom side.

Another run or two between 3:00 - 6pm. In addition to 3:50 & 5:00. EVERYDAY Mon- Fri they're over loads. Also the am between 6:20 - 9am there should be one more run. When you need it 5 x a week should we have to wait in line over an hour each way x 5 days?

Appears we need 2 ferry service on Thursdays in summer, as well as weekends and holidays. Need shorter gap in middle of day in summer months (maybe 2 ferries run through lunch times?). Contemplate reservation system, like San Juan's, in summer months (I'm on the fence on this one).

Response

Arrive and depart on time.

As a mainly 'holiday' traveler, the backups at those times is very disappointing. It would be great to have better flexibility in adding boats on those dates and making it more usable. The other main improvement would be a way to see current expected wait times. Driving to Steilacoom we never know how long the wait might be.

As a visitor, I am good with it!

As the population in the island increases, the number and frequency of ferries does not seem to follow the demand. The big gap in the middle of the day can be very inconvenient. When I have a doctor's appointment in the afternoon, I go to the ferry line at least one hour before the ferry to make sure I do not miss my appointment. But so do other people, and we can never know for sure that we will be able to make our appointments. There has been an increase in commercial traffic (construction trucks, for example) that really makes our planning difficult. There is no way I can know when it is more or less likely that trucks will be in the ferry taking up the space of several cars. If the ferries were more frequent, we could at least be sure that the wait for the next ferry would not be 2-3 hours. Sometimes, planning is impossible under these circumstances. I also had a few situations when the truck that was supposed to deliver us something large could not get in the ferry (

As we have to leave the island for Dr. and Dentist appointments as well as other appointments it is difficult to get back home due to the lack of mid day ferry's. Many procedures such as lab work or minor procedures are usually scheduled in the morning hours and if you miss the 12 PM ferry one is stuck on the mainland until 3. We are seeing a lot of growth on the island and by adding some mid day runs it may prevent not being able to accommodate everyone, when they want or need to come over.

At a minimum need a ferry to Anderson around 1:30 pm. I arrive more than an hour early for EVERY trip to ensure I get on. 2-2.5 hours waiting round trip! There shouldn't be an expiration on multi-pack tickets. and showing 7/2 expiration but midnight is the last ferry eligible on 7/1 as an example, is a joke. It should be for all ferry runs on 7/2. ***ENTERED FROM PAPER SUBMISSION***

At least 1 larger ferry, 2 ferries on the weekend, sell tickets in line

At peak times run two ferries to cover leaving so many vehicles waiting for next ferry an hour later when one is parked there, in site.

At this point I do not expect any improvement. I'm just hoping to avoid any additional schedule cuts.

Attendants at both ends of the ferry line to prevent lane cutting. Not having a fuel run in the middle of a holiday when 2 ferries are suppose to be running. An earlier run off Anderson in the morning.

Attitudes of the ferry users!

Availability of transit

BIG HUGE gap from noon to 2:45 makes both FULL-and-then-some runs, before and after, a terribly long wait.

BIGGER FERRY ANS PAY OUR WORKERS MORE SO THEY DONT QUIT!!

BIGGER FERRY!!!

Bathroom further up the ferry line for overloads or disabled who can't make it all the way down on the dock and back to their car before loading. Single drivers are stuck in line and have no passenger to move their car.

Because of the increasing population, it is common to miss 2 ferry trips. If you miss the 12:10, you wait until 2:45. That is almost 3 hours. The 2:45 and the 3:50 typically have 3 lines each. You must be in line 45 min to an hour early, and that is not a guarantee. They also eliminated a 9:35 run in the evening, so there is a 2 hour wait from 8:35 until 10:20. They are not reliable for appointments, airport trips. There are frequent problems with the ferry docks, mechanical issues with the ferry, and often notifications that it is running late, sometimes with no explanation.

Because the ferry is busy, and requires some pre-planning, last minute cancellations are difficult to deal with, especially 1st and last runs. The ferry is a service and should have a reliable schedule. ***PAPER COPY ENTERED MANUALLY***

Beginning each afternoon there is always an overload on each run back to Anderson. Could there be another run starting earlier in the afternoon to prevent "loading up" of the ferry lanes?

Being on time. The data does not correlate with any ferry run that I have been on in the last several months. For whatever reason, every ferry I have taken has been late.

Better access for commuting residents, more dual boat runs Thursday-Sunday, add designated commercial run days on second boat & fuel runs, improve ferry lane management we should not have to police the line as your customer,

Better communication about schedule changes, being proactive in helping the app stay current

Better job of fitting more cars

Better lane management...both sides Increase schedules during peak hours Ketron use unpredictable and impacts AI availability

Better line patrol to eliminate those that "cut" and 2 ferrys during the popular commute hours on weekends (Friday-Sunday) should be 12 months long - not just holidays/summer. Especially Friday evenings

Response

Better management and maintenance from Hornblower or better yet, get rid of Hornblower altogether! The crew is under terrible work conditions! Inconsistent schedules and horrible low wages is the cause that is making staff to quit and thus cancellation of runs. Above stated conditions also causes low interest in applicants. Also, lack of proper maintenance causes the boats, or components within, to constantly breakdown or be out of service...e.g.. restrooms and elevators. The newest revelation, the Fire personnel are no longer able to request emergency boarding for injured people unless they are being transported in an ambulance. This action costing citizens unneeded pain and suffering while waiting for a ferry. Unacceptable and unprofessional conduct from the immediate manager Steve. Refusing calls and failure to return or respond to requests for communication.

Better mid day service year round. The gaps are way too long. From Steilacoom there are ferries at 1035 1210 and 245. Every one of those ferries is overloaded nearly every day. 1-1/2 hours in the am and 2-1/2 hours in the pm is way too large a gap. Run ferries at 60-70 minute headway's throughout the day. And Fridays and Sundays from Memorial Day thru Labor Day should have 2 boat service on 35 minute headways from 9 am to 6 pm. This will require 10 hour work shifts, but worth it for reasonable mobility.

Better parking in Steilacoom for walk on passengers who live on Anderson island full time.

Better schedule with smaller gaps and Better training for the crew.

Better schedule, bigger ferry or 2 boat service between 7 am and 6 pm, a ferry run between 12:45 and 3 o'clock run from Anderson Island- too long a wait between runs and it backs up for the rest of the afternoon. Not so much emphasis on late evening service, overall reduce of what we have!!!! Been here 66 yrs- this is a mess!

Better schedule. Mid-day gap creates continuous crowding. Purchase specific trip tickets? More long term parking on Steilacoom to allow people to walk on and pick up cars on the other side. And/or good alternate mainland transport options look he affordable ride shares.

Better schedules, full two boat ferries Friday to Sunday on summer weekends. Priority to actual full time Anderson Island residents. Proper loading of cars on ferries.

Better scheduling and resource management to meet predicted demands. Focus on less cars with shuttles on both sides and more parking options on the main land to encourage walk-ons.

Better serve demand, daily overflow shouldn't be a given.

Better service from the contractor. Pierce County must improve their maintenance of the boats. Communication must be improved. For example, when there is a mechanical or staffing issue, there should be follow up explaining what happened and what steps are being taken to ensure it doesn't happen again. This should be communicated to islanders.

Better signage when lining up at the ferry on the Anderson island side

Better supervision for loading.

Better times for after school ferry rides, and adding a later ferry on the weekends

Bigger boat

Bigger ferry's , more runs use both ferry's during peak commute times. Passenger only ferry that makes more frequent runs than the vehicle ferry's. Priority boarding for full time residents designated by a pass or sticker. I've lived on the island for 3 yrs now and there is so much more vehicle traffic within the last 2 yrs. I've had to wait 2-3 ferry runs before I can get home which adds over 2 hrs to my days travel home. I commute to the Bellevue east side for my daily route for service calls. I'm stuck with a 2 1/2 hour plus commute there and back every day and having to wait an additional 2 hours to get home every day isn't a fun time.

Bigger ferry, better pay for the amazing workers so they don't quit. AS WELL AS BETTER HOURS FOR THE WORKERS.

Bigger ferry, better staffing.

Bigger ferrys or 2nd ferry on Friday, Saturday, Sunday and Mondays during the summer starting the same date that you start charging summer rates. If you have considered not having such a long interval between the 12:10 departure and the 2:45 departure from Steilacoom it would be a good idea to put that reasoning in writing for all of the ferry riders. I love island life and realize that the ferry is a huge consideration when making the decision to live on the island. That consideration has kept the island from being overcrowded up until recently. Now with so many people who have never considered Island life can now telecommute and not use the ferry on a daily basis. The issue you may be facing might have very much to do with that very fact. The island appears to be on a growth trajectory that makes any intermediate steps inconsequential. I wish you the best of luck and great discernment in this decision.

Boat size And times.

Both ferries in use starting Memorial Day through mid Sept on weekends

Both ferries run

Break from lunch to next run is too long

Build a Reader Board with times listed for all to see on both sides where the ferry docks.

Response

Cancel the daily last ferry run and add that run to about 1:30 pm. Increasing overall ferry runs will only increase housing construction and visitors, but the infrastructures, police, water, sewer, roads, medical care, are not in place for that.

Cancelling the two-boat service on Fridays and Sundays during the summer makes a significant negative difference for limiting availability and access for islanders to off-island services. Especially when it's a heavy visitor/guest weekend, making a ferry on one of those days is almost impossible. I had to get in line at 12:45pm, immediately after the boat left, to make the 3:15pm because there were no boats in-between. Leaving early also makes it difficult to make the boat if you're running late.

Capacity for driving on. There are way too many runs where a considerable number of vehicles are left behind... sometimes for 2 or 3 ferry runs before getting on. This is horrible for residents that rely on the service.

Capacity needs to increase somehow; bigger boats, running both boats, or, ?? We've been using the AI ferry service since the mid-70s and have never seen anything like the current amount of traffic over the last couple years. It's exploded and I'm not sure how this hasn't been foreseen with the amount of building going on. The more people with homes on the island, the more traffic going back and forth. Commercial/service traffic, residents, and their visitors/family/friends.

Capacity or second ferry

Capacity!

Capacity, number of runs per day, increased 2 boat service.

Capacity. So increase runs or bigger ferry.

Car loads are too high for the ferry schedule and capacity. Double ferries are great but even they need some scheduling evaluation and planning. In this past 4th...all on island knew Thursday would be the heavy day due three day weekend extending to Friday for most workers.

Change the schedule to include more mid-day runs without such a large timing gap. And run 2 ferries more often. Development on the island is booming and we have more & more people who are using the ferry than ever before.

Change the schedule. Too much of a gap in the afternoon. Please consider a different/separate lane for residents

Charge the trucks and non-island visitors more than residents.

Clearer rules about ferry usage. ((Gaps etc.)). All the stuff people complain about. I don't live on the island full time and don't want to make anyone come unglued by something I inadvertently do because I don't know the rules.

Response

Commercial trucks having more than two axles should not be allowed during peak hours. Residents should have a year-around rate, Visitors, AB&B guests, etc. should pay more.

Communication

Communication - keep riders updated on challenges and changes.

Communication about disruptions to service could be improved. Sometimes I don't get a notice a ferry will be unavailable until well after it's scheduled to take off. I'd like this information to share with my employer as promptly as possible. A way to prioritize residents reaching the island would be ideal. As a daily commuter there are too many days where I'm in line by 5:30pm but will not be home until 9pm. To have another attendant to help monitor the lines would help reduce the "he said, she said" line conflicts I see so often. Ultimately, I'm very grateful we have a ferry and a safe way to get home and to the mainland.

Communication with the riders about delays and if the boat is full when you get left behind for the next boat maybe people could get text messages or email when they sign up.

Communication, line rules, and staffing

Communication: the only way to know a ferry has been cancelled is through the app. A ferry was canceled once and we were left waiting: nothing on the website, facebook, or twitter. Communication about canceled ferries could be easily improved. The long gaps between ferries. The busiest ferries are around noon, so they tend to fill up quick yet if you're left behind you have to wait 2 hours. Ferries should be running every hour or if there has to be a gap, it should occur at less busy times of day.

Commuter lanes, increase ferry schedule - 2 boats! Walking on has been our saving grace but not everyone can do that. Parking issues...

Constantly having 2 ferries in use at all times and enough crew to manage the ferry lanes

Continue to offer a variety of times.

Continue two boat service during peak commute hours.

Continuous service all day. Get more crew to cover lunches!! At least during peak runs I have to leave home one hour before a scheduled ferry run in hopes of making a doctors appointment. Sometimes go to boats in advance to try to be on time. This is absolutely ridiculous

Cost, too expensive

Could use another run between noon & 2:40. Ketron island residents should have their own little ferry.

County support

Response

Create a system to give Anderson Island residents boarding priority over vacationers (i.e. - hang tags, windshield stickers, dashboard cards). Residents have appointments to get to and responsibilities and obligations to get back home to take care of.

Current schedule is not afternoon mainland worker friendly. Most are unable to make the 1810 ferry thereby having to take the 1920 getting home ~2000. Even worse in the summer months as the 1920 is often full and you have to take 2035 ferry

Customer Service. Consistent enforcement of rules and policies. A schedule that accurately reflects the loading and unloading times as to increase on time sailings; the current schedule

Customer service and ferry runs frequency.

Customer service needs improvement, specifically in the terminal. Accommodation of Ketron, needs to be reduced. The ratio of residents who reside on ketron full time vs full time Anderson island residents is significantly lower. Full time residents should receive some sort of discount on ticket fares, daily commuters have to deal with an influx of off islanders/visitors during peak season that highly effects their chances of not making a ferry they normally would make during non peak season. There's no control of that, I am aware, but full time residents get burnt over people coming to visit.

Customer service with the staff. Some of them are not very friendly. An alternative way to make the ticket work if the app is not working. (Instead of making customers take the next ferry.) A 'download to view' offline version of the ticket perhaps.

Customer service,(closing gate with walk ons running to get on, lack of consistency of policy enforcement) maintenance on boat, elevator frequently out of service, repairs to restroom not made. Improve salary of employees to attract and retain employees

Cut the last ferry at night - not enough users, and move the run to 1:20 p.m.

Decrease time between 1210 and 1445 ferry. Not sure why it appears the ferry crew gets an extended lunch break. Also, statistically, there is no reason to have the 2320 ferry. On average, how many cars are on this ferry every day?

Definitely MORE ferries running year round with more time slots. Having overflow situations on weekdays during the daytime, every month of the year is unacceptable.

Designate a late night ferry for fuel trucks!!!! It is ridiculous to use an entire ferry up and leave residents and visitors stranded!!!!

Direct and more frequently runs to Ketron. At least one direct at a reasonable time in the am and the early evening. Also a couple of runs a month to allow for repairs and services.

Discontinue completely. Those of us that live on the islands have the capability to be responsible for our own transportation across the water.

Response

Discounts for AI residents, double ferries during rush hour.

Dislike the big gap around noon.

Doing a two boat schedule all of the time

Doing what you say you're going to do! Don't tease with 2 ferries and then cancel them, which you do regularly! Properly load the boat. Most of all, run two ferries at all peak times! ***ENTERED DIGITALLY FROM PAPER***

Don't care, island residents should pay for most of it.

Don't know yet, ask again next year.

Double boat schedule is a must.

Double ferries around weekends all summer long. Maybe start that earlier, before July 4th. Getting the workers to regularly assist the parking on the ferry so more cars can fit. Take in to account that there are more people living on the island than there were just a few years ago, increase the size of the ferries or frequency of runs. I know none of this is economically feasible, but you asked.

Double ferries extended earlier and later in the season.

Double ferries in peak times as I understand a larger ferry isn't a current option.

Double ferry during high traffic times, specifically evenings. Someone to monitor the lines more closely.

Double ferry running summer and weekends. I've been left behind too many times

Double ferry's when needed.

Dual ferry more time during the year, a spot to fish on the wat

Due to population growth the schedule needs adjustment to meet the high volume needs.

During peak use, it is frustrating when you arrive 70 minutes before a scheduled departure and end up in overflow while your frozen food melts. This is not our vacation, this is our home and survival. Run two boats when overflow occurs or dedicate lane 1 to residents only (not Air BnB) (simple license verification) Or actually listen and not build a worthless, unsafe roundabout at the worst time in the season while letting our roads (Eckenstam/Johnson) sit out of service (one lane only) for THREE YEARS!!! No police, no services (weed mowing alongside our roads)...nothing!...while I pay you jokers over \$10,000/year in property taxes So, now you know (I think you already did...which makes simple incompetence into something premeditated and perhaps even criminal)

Earlier ferry and 2 ferrys more often. Fuel truck and heavy trucks and equipment should run a special ferry run that does not effect normal traffic runs.

Either bigger ferries or more two ferry runs. Current schedule does not work any longer for holiday weekends and weeks as could be seen on four hour plus waits on Thursday July 1st to get on Island and extensive waits to get off Island on July 5th.

Either larger ferry to accommodate more vehicles, or regular 2 boat service. Eliminate long-mid day break when ferry lanes start to back up for several runs starting around 3

Either need double ferries most days, give priority to full timers or bring in bigger ferries. It's crazy when a doctors appointment or going shopping requires hours on both sides. I'm not usually a complainer but this is out of control. For full timers this is our life and the ferry system is a several times a week thing. We don't have time to sit in line for hours. Coming and going. If you can't deal with it in a more reasonable way, turn it over to the Washington ferry systems

Either start to accommodate the demand for Anderson Island or turn the service over to the Washington state fairies so they can do the job that they do which is a lot better than you were doing

Either use two boats more often or increase of runs.

Eliminate last run during midweek

Eliminate service to Ketron Island as the ferry link does not connect county highways to county roads on the island. Ketron roads are private,

Eliminate that long mid day break.

Eliminate the last run and put a run between the 12:45 and the 3:15 - way too big a time gap - contributes to overloads mid day.

Eliminate the late runs and add another run between the 12:10pm ferry leaving Steilacoom and the 2:45pm ferry. That large gap is what causes most of the overloads.

Encourage less automobile vehicle loadings by offering parking options in Steilacoom. Moving forward, a larger vessel will be needed to accommodate the growth and popularity of Anderson Island.

Encourage more walk on's have a shuttle bus on the AI side to take people to certain predetermined locations le: General store, etc.

Enough to prevent overload

Entering vehicles plates should be scanned. Lower prices for full time residents.

Response

Everyone wants to drive right onto the Ferry like it is a floating bridge. The County is issuing way too many permits for new construction. Obviously, the infrastructure cannot support it.

Everything

Everything I just outlined in the previous question. Ferry times and schedule especially the gap between 1245pm and 315pm during the afternoon.

Everything... Add mid-day run.. Teach crew how to load Educate crew on truck use and tides

Expanding the 2 ferry service to Thursday through Sunday.

Extra ferry boat in the morning and another ferry between the 12:10 and 2:45.

FUNDING!!!!!! Pay them more

Fare rate reduction.

Fees for tax paying residents

Ferries that come more often mid day

Ferry capacity, we have outgrown the two current ferries. The schedule is unacceptable. There are very large time gaps in the middle of the day. Summer days when they have both ferries in service it works pretty well.

Ferry crews need to ensure that cars are efficiently packed on board the ferry. More trips should be scheduled during peak seasons (including the day before and after holidays). The ferry contracts should have performance incentives to encourage minimized wait times and penalties if vehicles are left behind after the last run of the day.

Ferry line monitor that manages lanes and two boat schedule and or more runs !

Ferry lines way too long at peak hours.

Ferry service should be every hour from 5am till 9pm.

Ferry service to Ketron around 3:30-4, please

Ferry should have longer hours of operation, so that residents do not get stranded.

Ferry should not be idle it should run all day every hour to not cause "left behinds" I would like to see the stats about the number of left behinds on the run immediately after lunch break. It is simply a staffing issue. Let's keep one of our multi million dollar boats going all day. There have been too many left behinds lately

Ferry times! Ketron needs an additional departure time between the 11:30am and 8:15pm times.

Response

Ferry times, using 2nd ferry.

Ferry traffic has INCREASED...a lot! Two ferries running more often! Ketron runs (for 12 houses) should be relegated to times that never fill up ferries. Holidays in the summers need double ferries for more days. Thursday July 1st had 4 hours waits. Friday had two ferries and still got backed up. I understand that public transit is always a next loss, so a balance must be struck, but since two ferry are already sunk costs...it is just labor and fuel, which should limit expense loss....

Fewer gaps during the day , which cause overloads on each side on the next run

Fewer people wanting to come to the Island. Clear directions on how to line up. No line cutters. Supervision to monitor lining up and loading. I do not think bigger boats or more runs is the answer, it only encourages even more people.

Fill in the noon/early PM large gap with runs. Add line attendant in spring/summer. Willing to pay for this.

Fill large gap in the schedule (between noon-3pm) so there is essentially at least one run every 60-90 minutes all day, every day

Fill the long gap between the 12:10 and 2:45 ferries from Steilacoom and the 12:45 to 3:15 from Anderson Island. Make Ketron passengers pay for their passage. Only go to Ketron when they make a reservation for only certain ferry times when it is not as full. There's only ?15 houses on Ketron and most not full time residents. No one else is allowed on their island so why do they get to ride free? They're not that special. Make a definite rule that there is no lane cutting ('filling the gap' per old-timers) after lane one is full. We've watched too many people play games with lane cutting and keeping others there before them from getting on the ferry. Put pull-down posts at the ends of the lanes to keep people from moving cones. Re-paint the end of the lines with red so people cannot equivocate that they didn't see where the line ended. Make sure ALL the ferry workers know it is no longer ok to "fill the gap" unless it is only in lane one when someone won't park close to another

Fill the midday service gap. A break between 12:10pm to 2:45pm is no longer acceptable in a world where people are needing to travel for work, school, etc. at different times and not necessarily during the traditional commute periods. A 1:20pm roundtrip daily would be great. Increase staffing to provide the two boat service on summer Fridays and Sundays. It has been cancelled more often than not this season. Expand two boat service to summer Saturdays. Saturday is quickly becoming the busiest day of the week for ferry travel in our region with an increasing number of people taking long day trips. Anderson Island could definitely get in on this with the right level of ferry service. Start the boat at 10am and run until 7pm. Expand two boat weekend service to start in early May and end in late September to accommodate growing levels of shoulder season tourism. Offer at least one sailing (ideally two) to and from Ketron Island during the afternoon. to better serve island resid

Find a way to eliminate the huge gaps in service which contribute to the overload problem.

Response

Find having to get in line for ferry hour and half to two hours before scheduled. Possible better schedule so you don't need to wait 3 hours for ferry run

Fire creepy ferry worker and always run 2 boats and get a vending machine

For kids to be able to get to and from school. And a later ferry on weekends.

For me, it all works well. Thank you.

For summers (mostly the month of July) and holidays and "heat waves" we absolutely need more ferry runs. AI is no longer a small remote island, it's a destination used by a lot of people.

For the three summer months you should run two ferry on Friday and Sunday. Also on the holiday weekends you need to run two ferry on Friday, Saturday and Sunday

Frequency mid day

Frequency of boats.

Frequency of weekend and peak periods needs to improve.

Frequency on high traffic days.

Fri Sat Sunday with "Day Trippers", rental people, etc is getting very challenging. Two boat service should start earlier. We need another run from Steilacoom side between the 12:10 and 2:45.

From what we can see it does seem that the increase in people who have purchased homes has increased the use of the ferry. Starting the two ferry service schedule earlier could be helpful. Possibly a walk on passenger only service could be beneficial as well

Full time resident passes that allow priority loading.

Full time residents should have priority passes when just trying to get home.

Full time residents should have a priority boarding line then it should be first come first serve.

Fulltime residents should have priority getting on the ferry. When I am going or coming home from work I should have priority over someone coming/going camping/vacationing.

Gap in service during middle of day. Better signage at top of Steilacoom lines for people not familiar with loading rules. Discontinue the use of plastic cards when loading! These things are just huge germ spreaders and staff did without them for over a year during pandemic with no problem. I see them as a liability.

Response

Gaurenteed 2 ferry schedule thursday-monday starting memorial day through labor day

Get rid of 10:20 pm run. Less people would move here. Last run was 6 pm for years. Will have to run both boats, and increase fares.

Get rid of mid day gap. It puts the whole afternoon behind.

Get rid of the Horn Blower manager. He is destroying the morale of the staff, no follow through on maintenance issues. Changes policy with no notice . And has no respect for the island tax payer. Provide a living wage for the crew and give them incentive to stay. Have some consistency in the day today operation of the ferry, enforce all the rules not just a few here and there.

Get rid of the huge mid day gap

Getting bigger ferries. Also your question # 6 needed to have NONE as a reply.

Getting left in line because of no room. Needing to be in line for 45 mins prior to departure on some runs or get left behind. 40 day validity on the tickets for people that live here full or part time. Increase to 70 days or at least 60 days. It's not that hard to shop for two weeks at a time. Better pay for the ferry workers so they can keep people and add more runs during peak times. Our two ferry schedules are impacted because not enough people to operate. Look at the records. Also look at the overload prediction, you'll see it's a known problem that we get left on the beach on certain runs and that causes at least 45 min wait in line periods. Rule of thumb; if you are in the 3rd lane you may get left.

Getting rid of the large gap of service in the middle of the day.

Give the crew a salary compatible with cost of living, so they have incentive to stay. Take over management and get rid of the 3rd party contractor. Increase maintenance to avoid future break downs. Provide consistency in the rules and loading.

Given the huge amount of new homes being built the ridership has and will continue to increase greatly. Just this year alone many many new residents homes built with many more permits pulled for even more. The ferry system does not support this increase in population, let alone the continued growth. This is a year round, 7 day a week problem. Those of us like my husband and I who have been full time residents for several year find it increasingly difficult to conduct our lives. Getting to grocery stores , doctors appointments, visits from family and to family who live off island now consumes a full day- must be in ferry line, both sides, an hour ahead at least in hopes of getting on. This means it takes 3 hours out of the day, counting both directions just to travel to the grocery store! An hour at least wait to get on, another 1/2 hour for the ride if ferry on time, each direction. When visitors come they often have to wait for another ferry because the one they wanted on is full. M

Have I stated earlier working on the hours I think would work better

Have enough staff to use the 2 boat system more often. Three Sundays in a row the second ferry service was cancelled because of not enough staff.

Response

Have the crew move all the cars up as close as possible to get as many on as you can. On AI on overloads have someone direct traffic to refill the lines for next boat.

Have to wait in line too long on high-traffic days

Having 2 boats at peak times. The ferry lines are overloaded every day

Having 8:15pm as the earliest possible time to reach Ketron after the 10:35am departure (which is often not accessible to working community members or families) is restrictive, and particularly difficult to navigate for residents with children. Additionally, late-night options for Ketron upon reservation, which are at a low traffic time for Anderson Island as well, may not be heavily trafficked but offers a huge amount of flexibility and assurance for Ketron visitors.

Having a second ferry available when the lines are exceptionally long. Not having such a long wait between ferry times in the early afternoon.

Having a ticket taker/line director at top of ferry lanes in Steilacoom.

Having a two boat schedule bringing passengers out in quantity on a Friday, then announcing it's not available on Sunday is a recipe for even more discontent.

Having commuters car pool, van pool or have parking options so they do not contest the ferry for us part timers. Military discount would be amazing!

Having hourly service instead of leaving gaps on certain times during the day.

Having more runs in the afternoon all the time, not just summer weekends, and having another run instead of a long break between 12:45 and 3:15 would be really helpful with having to make appointments for doctors and things. There is always a lane left behind, or two in some cases, when the ferry picks up at 2:45pm from Steilacoom, and it continues until the 5:00 on a regular, non-holiday- week day. There are more people coming to the island and moving to the island now then ever before.

Having someone monitor the lanes. Clear signage about how loading the ferry works. More ferry service at busy times

Having the double ferry schedule expanded to more weekends beyond summer

Having two boat service everyday or Friday, Saturday and Sunday all year long.

Having two boats running more frequently.

Heavy trucks pay more - and should never bump normal traffic

Holiday weekends should start 2 boats on Thursday through the following Tuesday. I and so many others waited 3 THREE HOURS last week to get home. That's ridiculous and unnecessary. Even today, Thursday the 8th, they are leaving people behind.

Response

Hornblower is not a good company. We need to stop looking at the lowest bid, and start making smarter decisions. Ketron residents don't deserve public ferry service since they are a private island. Make them pay full rates for crossing, like \$50.00 per vehicle. Gas costs from taking one car to ketron inconvenience everyone and bring down the bottom line for the hired company, currently Hornblower.

How people are not made to Follow the rulers of no line cutting etc

I am an educator and am concerned with the lack of ferry service times for school aged children who live on Ketron. I attended steilacoom schools k-12 and had friends who rode the ferry to Anderson. Ketron is not a viable option for residents with school age children who want to attend school in person. This is very concerning to me.

I am not educated about it. 2 ferry service on the weekends.

I am not qualified to comment.

I believe the ferry works fine, some of the commuter times could be adjusted better like a 5:30pm ferry instead of a 5 and a 6:30 instead of a 6:10pm. There are other times that could be relooked at, but none of this is critical. The real critical issue is there is always going to be overloads and full ferry lines especially during the busy season. The real thing is getting people out of their cars and providing reliable parking on both sides and right now that is the Steilacoom side.

I believe the gap between 12:10 and 2:45 is what causes terrible backups in the afternoon commuter times. If we could add a run between then, that would be great. The Ketron run at 6:15 is very inconvenient for many islanders, and I wish it was a regular run. Maybe do the morning Ketron before the 6:15 run.

I dislike the lengthy interval in the middle of the day. I would like the ferry operator to have more flexibility to add an extra run and or second ferry when demand is sufficient.

I do not have enough experience to say.

I do not like 70+ minute breaks during the day. It's horrible to have huge chunks of time during the day that cars pile up because there is a larger break between ferries. There should be two boats every Fri-Sunday May 1-Oct 1. Avoid overloads. Avoid overtime. Plan for extra ferries.

I don't know exactly how to do it, but there should be some sort of preferential loading. eg. 1) Residents, 2)Service Providers, 3)Visitors. Currently we have to be in line at least 45 min. prior to sailing to be SURE to get on board. Far too long a wait between the 12:10 and the 2:45 from Steilacoom.

I don't use it. Why should I pay for it when I don't use it and then still have to pay a fee if I did.

Response

I doubt all the workers that scan tickets remember exactly what cars they've done. There was an instance that we could've gotten on free due to this. The ferry times aren't spaced well throughout the day. There is a huge gap at lunchtime which can cause overflow on all the afternoon ferry's. People that live on the island shouldn't have to worry about not making the last ferry of the day. Having to wait three ferry trips is a little ridiculous.

I drive a Smart Car, 8 1/2 ft long. Two of these can fit into the commuter length limit. A reduced fare for really short cars would spur people to use their small cars instead of large cars and trucks. The Washington Ferry has a reduced fare for short cars, increasing capacity. Please don't spend more money and increase fares to make it easy for people that don't want to use the times when the ferry is nearly empty and want to leave/return during peak times. Higher fares during peak times might also shift people some, increasing efficiency. I would actually like to see an earlier, say 3:00 AM ferry so I can avoid Tacoma/JBLM/Olympia rush hours, and a midnight or so ferry so I can return after a hike or late dinner out. Unfortunately, I don't think with the current system there would be much ridership when every trip costs the same.

I feel that we need a larger ferry or more runs provided May through September and weekends all year long.

I find it difficult to commute to work on Thursday and Friday anytime during the summer. I frequently spend hours in the ferry line, after a hard day's work, loaded with groceries, trying to get home to take care of my pets. Instead of a normal commute, I have to wait behind people who not only don't live on the island full time, but their guests, loaded with RVs, jet-skis, loud music, pleasure boats, etc... Create a priority boarding system based on points. 1 point if you own property on the island 1 point if you live on the island 1 point if you commute Then have people get in appropriate line based on their points. 3 points: Row 1. 2 Points: Row 2. 1 Point: Row 3.

I have a lot of stress about missing the ferry. This could influence our decision to build on the island. I think reservable overnight parking on both sides of the ferry would be helpful. I have also heard many complaints about people cutting in line. That could be managed.

I have no idea

I have no informed comment I can add.

I just received a message that the second ferry scheduled for tomorrow will not be available. Overloads continue to increase due to population growth here and high increase of visitors coming to the island now that they discovered it is a close, to the mainland, get away.

I realize that I am in the minority, but I've noticed that every time more ferries are added, there are more users and the overloads get worse, not better.

I said it all on and swearing the previous question... []

Response

I see that the sherrif is helping out on some of the really busy days directing traffic as it relates to overflow. However there are times when no one is at top of th hill and it becomes very confusing especially with newbies. Perhaps some sort of explanation on website as to how the ferry lines and boarding work. The proper ferry line etiquette etc...

I strongly suggest a few service improvements! Ferry should have a dedicated day or two that provides service for commercial delivery. Example Tuesdays and Thursdays. Dedicated parking should be provided for island residents near the Steilacoom side. Lastely, permitted prioritized boarding should be available for island residents. Thank you for these considerations. - Donny O.

I suggest it's time to reconsider serving both islands with a combined run. Perhaps the triangle is still appropriate for off peak mid-day traffic but it doesn't seem like the best use of resources to leave extra vehicles behind at Anderson to pick up a few customers from Ketron considering how quickly that can be addressed independently. Also, restricting ALL trailers because of an arbitrarily chosen tide height when only very few low clearance vehicles have a problem clearing the hinge is extremely poor policy when managing a public transportation system. The bus system does not impose any size restrictions because a few times a particularly large passenger got stuck squeezing through the doors. More and more I've experienced these types of management decisions and policy changes that further degrade service than have I seen efforts to maximize service in the face of challenges. The system needs to be robust enough to meet the needs of the communities it is serving while still mai

I think doing away with the 2 hour waits in the afternoon would be appreciated, because then that would give me more leeway. Plus, I think adding carpool vans or buses with parking on the mainland and Anderson would be hugely beneficial and not as impactful. Also, with more people building I wonder if it's possible to stop issuing building permits until the ferry issues were resolved and we had a land use impact statement and a potential quota of capacity Anderson island can handle. Plus, restrictions on STRs would also be reasonable as a lot of ferry issues seem to be on major holiday weekends like this last fourth: on Thursday July 1st was 3 hour waits and then Monday July 5th 1200 people left Anderson. It seems like we're kinda like the wild west and I fear we will become one of the tragic communities that over builds and we run out of resources.

I think it is fine as I rarely use it.

I think it's good as it is.

I think the roundabout will be an improvement

I use the Pierce County Ferry 5 days a week, I get off at 4:30 and have to wait almost 4 hours every day to get home to my family.

I want to be sure that the ferry attendants make a good living.

I would add another ferry during summer, wait times are long on a daily basis and even harder on holiday weekends. Would also be helpful to extend the service into the 11 o'clock hour.

Response

I would designate three (3) morning, three (3) afternoon, and one (1) late evening runs as Ketron Is. on-call (i.e., by appointment); and, that Ketron Is. be the first port of call, rather making Ketron Is. bound passengers make the unnecessary trip to Anderson Is.

I would have many complaints were I a regular commuter, or if my kids were still living at home and commuting to school, etc. Parking in Steilacoom has always been a problem. I don't have to be so concerned about such things anymore personally but I see what a nightmare it can be for those who need to get to the mainland and back home to the island again on a daily basis, especially for doctor appointments and the like.

I would like Island residence to be given a preference over vacationers to ride the ferry, residents should not have to wait in long lines for a half a day or more to get back to their home.

I would like less if a gap at noon time to 2:40 in the off season as well as later leave time for the last run from Steillecoom. More people on Anderson and Ketron plus more heavy equipment have made guesstimating your chances of boarding from the middle of lane 2 surprisingly poor.... Some kind of early warning, as we do with tides, for unusual loads that impact typical flow.

I would like there to be a ferry service between the 12:10 and 2:45 ferries. The wait is too long.

I would like to have more runs around holiday weekends, and extend the months offered into May and September. Lines are too long and too many people end up left behind.

I would like to have two ferries run Thursday through Monday all year round

I would like to see less of a break mid day, and 2 boats all weekend days not just summer and Friday and Sunday's.

I would like to see the long gap filled. Mostly the space between the 12:10 and 2:45 (Steilacoom), and 12:45 and 3:15 (Anderson Island) . Too long of a gap. The ferries before and after these times and at noon are super full, because of the gap. All three of these times, you have to get there early and wait for at least an hour to get on them. If you only did that during the summer, that would be nice.

I would use ferry more often if I didn't have to wait hour or more to get on ferry and sometimes 2 hrs. to get home. Such a waste of my time. Therefore, I try hard not to go to town except for necessary stuff. Now, because of our huge growth, it is a real nightmare especially for older people like myself. We need a change fast!! Thank you for doing a survey.

Response

I'd like to see an account/pass similar to the WSDOT good to go service that would allow island residents the ability to load a prepaid account. Which could be charged whether you are walking on, driving on in different sized vehicles with or without passengers.

I'd like to see more evening and weekend runs. As well as after school runs.

I'd pay more if it allowed for a more frequent ferry in June and later ferries to allow for attending concerts, the theater, etc.

I've noticed that few use the late 10:20 ferry during the week. Suggestion: keep it only for Friday - Sundays. Realizing that the departure from Anderson Island doesn't arrive in Steilacoom until 1:15 and that there is training and a crew-change involved, please see if there is any possible way to shorten the time between the 12:15 and 2:45 departures. Please note that the last 2 or 3 ferry changes have not helped the overflow situations. They appear to have increased. By accommodating the complainers, the ferry is more accessible, attracting more usage. More ferries, more people, same or worse overloads. Please don't add more runs.

If I could get to work and then back home

If the schedule were more like Washington State Ferries schedule.

If there were more parking available in Steilacoom you'd reduce overloads and demand for two boat service. Too many people drive on alone.

If we can't have a larger boat then increasing the number of ferries running per hours is totally necessary.

Illuminate the gap between the 12:15 and the 2:45 ferry. You either have to hurry and have not enough time to do your chores, or you have way too much time to wait for the next boat. Also, Ketron run, when coming from Steilacoom, go to Ketron first, then on to Anderson Island. The way it is, you pick up 50 people on AI, and force them to spend an extra 15 minutes en route just to pick up one or two people from Ketron. The needs of the many outweigh the needs of the few. Go to Ketron first and let those few cars absorb the extra route time instead of the AI folks, who are your bread and butter. The logistics are the same, so easily accomplished!

Improve access in Steilacoom

In need of more options including direct to and from Ketron

Inconsistent loading, extra afternoon run before 245. Smarter commuters in lane filling

Increase capacity during peak times by having two boat service or a larger ferry.

Increase daily runs, increase service runs.

Increase number of runs

Response

Increase runs Fridays and Sundays

Increase the ferry's availability to meet the increased demands.

Increase the ticket prices to reflect the cost of operation.

Increased runs to Ketron. Direct runs, Afternoon runs, Mid-day runs. This would also help to get service providers out to do jobs without such a hassle to property owners & increased costs.

Increasing round trips with the use of both ships. Having later night runs. 11pm from Steilacoom. Ship just sitting there not collecting revenue when it's VERY apparent they both can be filled running at the same time. That should be a Port Captains call (as needed). Not one made by a suite and tie at a desk who doesn't even use the ferry. Love to see a cost benefit analyses. Ever do one. The cost associated with a round trip is ridiculous compared to state run ferries. You lose your pre-paid if you don't use it? really... Nothing positive other than will eventually get back and forth as painful as it is most the time. Like we are paying for a Bentley Limo, but actually getting a Mazda Miata. Nothing wrong with the Mazda except it can't carry the amount of people that need to be in it at the same time to get where they ALL need to be. But ALL would certainly fit in the limo we are paying for. We have no choice. Meetings on the matter is nothing more than a facade. Nothing changes.

Individuals who pull into the lines need better instruction regarding the elimination of gaps.

Investing in bigger ferries, strictly enforcing the loading sequence lanes (crack down on cutters), run two boats when there's a significant demand such as the THURSDAY before the 4th of July - ludicrous overflow volume.

Is the repair completed on the Steilacoom Ferry Dock. A couple of months ago, a ferry worker said it wasn't being worked on diligently to meet the deadline.

Is there a way to reduce the price on vehicles between 22 and 30 ft?

It does not seem reasonable to have to wait more than 1+ hours to get a ferry, let alone 2 to 3 or more hours. When I worked I had a car on both sides. It was necessary.

It is a long wait when the 12 and 12:30 ferry overloads. I assume personnel shift parameters don't allow another run for nearly 3 hours, But it would be nice.

It is a short distance and yet we have a long wait between sailings. In fact in the middle of the day is worse. We were promised 2 boats every weekend of the summer and we are getting them plus many of them leave vehicles behind. There is a solution. Arrange for parking so islanders can leave their car on the mainland. We can always find a ride from the Anderson dock home.

Response

It seems clear that this island has been growing in population, especially with rentals like Airbnb growing in what seems to be an unchecked fashion, the ferry system is not keeping up. Somehow, we need to be running both boats all the time, so that working people are able to get back-and-forth, without having to spend hours and hours waiting for ferries, and or possibly missing work due to overcrowding. I have noticed, being new on the island, and needing some repairs to my new home, though it's very hard to get contractors to come here because of the ferries. Obviously there is lots of building being done on this island, because there are constant massive construction vehicles, some towing other massive equipment, taking up many spaces on a commuter ferry, and that clearly isn't working. I am very aware that some of the other islands have far better service, also at a lower cost. So far I've had minor difficulties with the ferry, but I am really hoping it doesn't destroy my being able

It seems in the summer, starting June, the runs are very full. You need to be in line one hour early to get on. I would go in non peak hours but the schedule with the large gap between noon and 2:45 just doesn't work.

It seems like every time I use the ferry, there is overflow. There needs to be at least 2 more scheduled routes daily (not just on Fridays and Sundays during the summer). It would be great if the ferry held more vehicles. Honestly, I'm not sure if I will stay on the island because of the ferry. It creates anxiety not knowing if I'd make the ferry, even if I arrive over an hour early.

It seems like the gap is too long between the 12:10 and 2:45 ferries from Steilacoom. Because the 2:45 always seems to be an overload, it tends to make the following runs overloads also.

It seems there are more daily commuters, and there need to be more rides during commute hours, or a bigger boat. If I miss getting on the 7:35 am boat I will be at least an hour late for work. And every day, there are people who miss it. So I sit in line for an hour to try to make sure I'm not one of them. Also, the extra rides on Fridays and Sundays during July and August really need to be extended to the entire weekend. Again, a larger ship would probably help but not sure that is cost effective.

It works fine, I am glad I don't have to make reservations to access the ferry like in the San Juan Islands.

It would be great to have an electronic sign on Anderson Island that says the next ferry time, notes which lane(s) will load first, second, etc. and tells people to move their cars to lane one after the ferry departs. Too many people do not know the protocol, especially during the summer. The ferry is a service that is supposed to serve the needs of people wanting to come to and from Anderson Island. But sometimes it feels like we are a burden.

It would be great to visit our friends more often and to have a weekend option and later nights as well as after school runs for schoolmate kids.

It would be nice to have a parking lot close to the ferry (paid slots that are reasonably priced would be good) to make walking on with groceries/supplies easier. Also - would be nice to have the ferry landing equipped for walk-on only when boats are down.

Response

It would be nice to have more frequent runs during predicted overflow times

It would be nice to see more double ferry schedules starting Thursday evenings through Sunday evenings to lessen the missed ferry chance during the heavier commuter times for visitors and vacationers.

It's still a unique situation coming from the pandemic, but it's certainly impacted the volume of people calling this island 'home'. We've lived here nearly 9 years and appreciate the ferry service greatly. But over the past 18 months, the demand has grown to a place that we have to consider the overload on the current ferry system and providing for the future. With more working remotely, this is a new 'home' for now. Ad for those of us that do consider this home, the impact is crippling. My hope is that we provide a 2 boat system year round. If it increases the ferry rates, then fine. The inconvenience of missing important appointments off island would offset that issue - in my humble opinion.

It's time for a larger ferry. People should not have to wait three or more hours to ride the ferry home.

Just stated on previous page. Must say all of the ferry workers are always so friendly and helpful.

Keep in mind that DSHS runs their own Passenger Ferry and Cargo Barge, probably at great expense. Pierce could probably run it all from 2xFerry and one Passenger Ferry at reduced cost, similar to the way Ketron is handled. As DSHS if there is efficiency and you might get another payer in the mix. Could it be a win for all?

Keep it the way it is so less people move here

Ketron Island is the tail wagging the dog. Too many side trips to Ketron and too often get bumped because of cars going to ketron. Ferry often leaves 2-3 minutes early when there is no reason for it. Sometimes get stuck in traffic and arrive at ferry with 3 minutes to spare only to have them shut the gate in my face. Also, frequently leave cars behind when there is room for more. Crew does not treat ferry patrons like customers.

Ketron Island needs an increase in Daily runs. Ketron Island also needs direct runs restored. Ketron Island riders should not have to spend almost an hour on the ferry for what could be a 10-minute ride.

Ketron island more runs! There is a greater than 8 hour gap between 11:30 a.m. and 8:15 p.m. where there is absolutely no service for Ketron. This is unacceptable! There needs to be at least one additional run during that time. Ketron Island needs more direct runs. It is not fair that Ketron riders should have to sit on that Ferry for an hour when it only takes 10 minutes to get to the island from the mainland.

Ketron needs more reasonable times and more often.

Response

Ketron needs more reliable and more frequent service via the Steilacoom-Anderson crossing. I was very disappointed and inconvenienced that the Ketron ferry has recently experienced limited runs, particularly in the p.m. This unnecessary limitation has impeded both my ability to access the island or mainland depending on the time, but, more importantly, has severely impeded the mobility and needs of the residents of Ketron island.

Ketron needs more runs. Especially a midday or afternoon run. And we need our late evening run back at least for weekends and holidays. Direct runs rather than sharing runs with Anderson would be nice.

Ketron needs two more runs per day. Preferably mid-morning and mid-afternoon. As it is now Ketron receives only three runs per day. This is absolutely in no way sustainable for the pursuit of a better life on Ketron Island.

Ketron should have livable ferry runs! We pay the same taxes we pay the same fare we go a hour out of the way every run to ketron. Ketron should have a say in how the schedules are decided if we always lose out. There should be notification and a reschedule if you take away a service run last minute. Residents should be able to catch at least one late night ferry to enjoy things on the mainland.

Lack of inexpensive and sufficient parking in Steilacoom discourages walk-on traffic creating auto overloads There is a large unused passenger capacity. That is underutilized due to parking and transit issues on mainland. It would be much cheaper in long run for Pierce County to acquire parking lots in Steilacoom than to purchase larger ferries or create more runs. The town of Steilacoom owns lots by ferry. Another is owned by investors. In the near term the State is going to close the Special Commitment Center on McNeil. This will alter the parking available in Steilacoom. The County needs to be proactive and be ready to acquire these parks lots when they are no longer needed for State workers. The county should begin negotiations for their purchase now and not wait for the closure. New legislation requires an change in how the State houses DSHS inmates. The new rules provide for smaller facilities distributed across the state. Please read the McNeil long range plan that the le

Larger Ferry size. Most times need to get there 45- 1 hour to guarantee we get on. Or maybe 1 or 2 extra runs.

Larger boat

Larger ferry with more frequent runs.

Later ferry in the evening. More ferries during summer months. Reduce cost.

Later operating hours, cheaper tickets, disability access

Later return times on Fri/ Sat. Year around.

Response

Later rides to the island for those who have evening activities. Numerous times I've had my kids' friends crashing at my house because they missed the last one especially on prom type nights or football games, etc.

Letting the full time people on ANDERSON Island go on first!

Lighting in area at night, especially on the dock area.

Line control, and more runs (2boats)

Lines

Lines are getting longer and I tend to get nervous of last minute delays or cancellations seeing the recent emails. Hard to plan a specific ferry ahead of time. Checking tickets seems like it could improve, I've been skipped multiple times which loses money. With construction on the roundabout, communication will be needed.

Lines have consistently been long for some time now and not just on weekends, holidays, and summer. It's difficult to see the second ferry just sitting there when it could be used to reduce these long lines more frequently. Also, it can be frustrating when some of the workers don't put much effort into efficiently loading cars so that the max is reached. It's as if they could care less how many get on. (We appreciate the cheerful African American man who is packing them in, directing cars, as they pull into their space...always with a smile on his face!)

Loading of the ferry. Some staff are better than others with loading and frequently cars are left behind that could get on if loaded properly. It would be nice to have designed times for trucks and other vendors that serve the Island

Loading procedures to eliminate gaps and cutting.

Response

Loading the ferry, pulling cars closer together to allow more cars on. Some crew are great, others leave a half of a car length between vehicles and leave more cars behind each run. Getting, training and keeping good crew. Training for management (teambuilding, communication etc) to facilitate staff satisfaction, good work environment, so they want to stay.

Long gap between 12:10 and 2:45 boats often cause overloads for the rest of the day. 5:00pm boat makes it difficult for most workers, need to move back to a 5:30.

Long mid day break is ridiculous - it backs up the rest of the afternoon. We were told this was to allow one family on Ketron to send their kids to school - doesn't make sense especially since Ketron people DO NOT pay ferry fees and no non-property owner is allowed on that island. AM ferries have too many contractor trucks from Steilacoom and too many trucks returning at all times from Anderson. Wait times for ferries in afternoons at Steilacoom and at 9 and 10am ferries off Anderson are long because if one doesn't get to ferry line 1 hour ahead, you'll have to wait for the next one, especially on Mondays in summer. So 11 am is always full and 11 am always goes to Ketron only for one or two cars - why can't they have a time when it isn't as busy?? If Ketron doesn't pay a ferry fee, then why does the whole system get to revolve around them? We don't need a 10 pm ferry on most week nights - add it back to 1pm.

Longer hrs

Lower or eliminate non-user taxes. Why do we have to subsidize people's island vacation/residential homes?

Make it a law that cars must turn their engines completely off while waiting in line for the ferry

Making sure the 2nd ferry is running as scheduled during summer months - so when I need to drive on, I have time to get my car in line and still make the 12:45 pm ferry on Sundays. Having to wait over 2 more hours, or cutting short the work needed at the congregation are neither good options.

Management, the contractor, communication, the pay for workers on boat only. Less overhead on county side.

Mid day service should not have such a long break. More frequent two ferry service.

Mid-day ferry. The gap between 12:45 and 3:15 is inconvenient. Waiting time to catch the ferry is too long

Mid-day schedule is too spread out leading to overloads from noon to 5 or 6 pm virtually every day. The most recent change in the schedule, i.e. increased spacing between runs, has led to people moving off the island because it adds an hour or two to their workday commute.

Midday ferry- schedule without the gap!!!

Response

Midday needs an extra run. It is much too long to wait in a hot car to get in line an hour or more ahead of time and sit in the sun for a long wait.

Crew attitude towards riders can be snobbish and condescending. Ketron Island is costing the county more money than the island is worth visiting. Ticket prices for Ketron should be increased in proportion to cost of increased duration of ferry ride to visit Ketron, or Ketron should acquire their own ferry services, as the island provides no public land for any other ferry riders to visit. Additionally, Ketron riders get priority over Anderson Island, being able to get in the front of the line and needing extra space causing increased overloads.

More "two ferry times" on weekend high volume routes. More parking on Steilacoom side that would allow walk ons.

More 2 boat ferry schedule, Pierce County take control of system NOT hire it out to another company. I never dreamed back in 1955 when it was a 9 car ferry, service would ever be this much in demand.

I happen to work for transit in this region. Where I work if there is a lack of employees to do the job then a manager steps up and fills the shift. Well, apparently not in this organization. I asked to speak to a manager and the employee stated that the only manager onsite during the weekends is the Captain. I was shocked. The captain cannot be the manager and drive the boat. How is it that there is no managers present at this organization on the weekends? Especially during the summer and high traffic volume. Who is driving this "clown car" Pierce County?

My greatest concern is options for daily commuters, and if I go back to being one in the future it may likely mean moving off island full time. The mornings off island and evenings back on island are crowded and made worse in the summer with visitors. Parking options and transportation are limited on the steilacoom side for walk-ons either direction. For island visitors we would love a place they could park their cars for 2-3 days/more long term parking vs the lot where you have to go in 12-hour max increments (at least that is my most recent understanding) and it gets expensive.

Need more runs to accommodate the number of passengers and vehicles OR better parking options

Need more times available. Lines are too long

Need more trips. Need more frequent 2 boat service during peak times, especially during the summer. Do not have the 2 1/2 hour break after the noon ferry. That causes overflows and backups always. Population has doubled since we bought here, but ferries are still the same capacity. The system needs to try to grow or catch up some to the rapid growth in population and demand here. Thank you.

Need one more ferry between 1210 and 245 from steilacoom

Need to add two more runs during the day to reduce wait time.

Need to enforce waiting line/queues rules...eliminate line-cutting. Give line attendants the authority to cite violators.

Need to increase car capacity or implement a more efficient line system for the cars, because the amount of people on the island has increased exponentially. As a college student with little income, it is almost impossible for me to afford the ferry tickets as they are, they are extremely expensive.

Need to provide two ferries during peak times during the day. The boathouse needs to put some tables & chairs back inside for those waiting for the ferry.

Need to staff up for full 2 ferry service Friday through Sunday from 4th through Labor Day.

Need two ferries running so rides can be closer together during commuter hours, esp the morning ferry and weekends

Offer more ferries at peak times. Get a bigger ferry.

On busy weekends DO NOT do a fuel run, run double ferries all day, have ferry crew member assigned to Anderson island side to monitor the line, look at what boats are commonly overloaded and adjust the schedule to avoid this.

Once an hour would be nice

One additional run before 1 PM

One more boat between noon and 2:45 would be great

One of the biggest concerns is in the summer. They are NOT running two boat schedules on Fri or Sunday due to lack of staff. The overloads have become very crowded. I waited for three boats before I could load. It would also be great to have a ferry pass for residents, as of right now we can only pay for a 5 pack car and driver , why can't it be a monthly pass like WSF system? The lack of crew due to low pay and inconsistent scheduling is not helpful. I also feel that only the Riviera gets priority in ALL say of what happens on the island. It's been my experience that because I am a new resident, only three years, that I am an outsider. That is why I don't participate in any AI community meetings. Living outside the Riviera has its benefits but lacks support if you want a voice to be part of a community that doesn't like " outsiders". I hope you listen to what residents have to say. Thank you.

Only schedule changes! Crew members are GREAT! Facilities on board are well maintained in my experience. Online ticketing is awesome!

Only thing i can think of is consistency with pulling cars close to each other to be able to fit the most cars possible on the ferry

Operate the service like you must rely on it.

Response

Organize lines better to disallow cutting or what some call "filling the gap". Most that "fill the gap" do it to not miss the ferry. Those who monitored the lines in summer to stop the lane cutting quit as were volunteers and people were threatening and ignoring them. Need to hire someone with the ability to give tickets to stop lane cutting in summer. Tickets need to be substantial to stop this practice. Some laugh at a \$48 ticket and there's no one to give them a ticket. Add a zero to the ticket to make it matter. The only way to change the gap behavior is to hit them in the pocket book. Even some of the ferry workers think it's ok to "fill a gap" - they need to be taught it is not ok. Anderson Island side needs pull down gates at end of lanes and someone to monitor those who cut into lane 2 when there are people in lane 3 already. One incident that happened to us was a guy (contractor who lives on island and knows better) cut across Larson Road to get behind us in lane 1.

Overall service. Peak demand for the ferry has increased significantly over the last couple of years. Two boat service on Fridays and Sundays for half the day and only two months of the year is no longer sufficient. As a daily commuter my days have gotten much longer as I frequently get overloaded throughout the week when just 2 years ago there was never an issue catching evening ferries home after work. There is high turnover with the crew which leads to poor direction and parking of vehicles on the ferry. There has been a lack of maintenance on the docks and ferries which have caused major impact in recent years. There is no published contingency plans for when we do experience outages whether that be due to a dock issue, ferry issue, or crew staffing issue. There is insufficient parking on the Steilacoom side to promote more walk-ones for daily commuters.

Overflow management and prediction of increased ridership for not only fri/ sun. Obviously a greater need for more ferry runs in the summer especially. As a commuter I cannot get home sometimes until the last boat due to overflows.

Passenger drop off / pick up along Villa Beach Road NEEDS to be addressed. The noon boat frequently fills early leaving service providers in the ferry line for 3 hours because of the long gap in the schedule.

Pay the crew more

Response

Peak ferry/travel times especially in busy months are exactly when the ferry doesn't run. The noon and 2:45 pm ferries are a disaster and most of us alter our schedules around those to try to avoid. With the increase in riders - there needs to be consideration for a 11am and 1pm ferry. It is just not going to work without that. The ferry that runs extra on Friday's and Mondays helps but it's not just July/August that needs it anymore. May and June are getting crazy. For example the double ferry for this Sunday is already cancelled. I would encourage you to not just look at the numbers for the noon and 2 PM ferries many of us change our habits because we have to avoid those times so if there was an additional time there would be additional riders so the numbers don't give the full picture. One of the issues that Anderson Island is struggling with is daily visitors so people come out to use the facilities that aren't members at the parks that are private and that generates a lot of daily us

Perhaps a little more organization at the top of the ferry lines in Steilacoom due to overloads. I understand they're going to put a roundabout up there, which personally I think is a great idea, however it may exacerbate the problem is people have with where to go and how to act during overloads

Perhaps posting a sign or two regarding driver etiquette relative to being in their vehicle in the line as soon as the ferry lands for off-loading! Passengers as well! Recently there have been multiple occasions when the loading stops due to thoughtless reorganization or riders not at the vehicle when loading begins. Rude and difficult for ferry crew. I believe the crews are well trained, very patient and kind. They should be treated that way as well!

Personally, I like the ferry and the natural limits imposed. It is the entitled users I cannot tolerate. It is an island, people. Live with that. We do not have a bridge. If you have issues, move to a place connected by road.

Pierce county could start by caring and giving a shit about this broken ferry "service" they "run" Tickets should be scanned at top of lanes before entering, no cards that spread germs (Covid). When scanning ticket before getting into lane the ticket person could tell bigger rigs to load in Lane 1 for inside lanes and all sized vehicles in appropriate lanes for maximum loading and weight distribution. By having ticket booth or person at top with lanes roped or gated off nobody can cut, all vehicles would be in line ready for a quick loading saving time too. The boat needs to run every hour with no 2 hour gaps around noon. Get a bigger boat, get a staff that is dependable and pay them appropriately so there are no ferry Employee shortage having to cancel runs, do fuel runs early morning or late, no canceling runs for fuel truck. Make a fourth lane or a designated overflow area that is not confusing and causing aggression or fighting because there is no clear directions and people parkin

My wife and I own the big house at the North point of Ketron Island. We own several businesses in Olympia and Olympia is our main home for 52 years. We bought the big estate at Ketron for our retirement house. I work from home at my two jobs. I work for Washington state government and I am also a commercial real estate broker and investor. I also have a recording studio at our Ketron house. My wife does not have the luxury of working from home like me. She / we own several restaurants and she is extremely busy. We pay a lot of money yearly to pierce county for taxes for our house on Ketron yet she can never use our Ketron house because the ferry to Ketron is so infrequent and then you recently cut the late evening ferry, the only one she ever used. In the past, because her / our restaurants close Friday and Saturday evenings in Lacey,

Please see prior responses! We have two boats, let's use them! Why does the county serve a private island (Ketron) and why does the main commuter run from Anderson Island now stop at Ketron island? Why can't AI residents use the "Ketron " only dock in Steilacoom? With the current growth on the island, the ferry traffic is going to overwhelm Steilacoom (three lanes plus overflow) and a roundabout that is likely going to be very challenging for busy weekends unless someone is at the top directing traffic. The solution really is either more runs, use both boats, or bigger boats. Taking away runs mid-day, was a huge mistake, in my opinion. Please!! Put a toll booth with employee at the top of the hill during busy times!! People are still unsure how to line up, they leave gaps. People cut. A lot! Usually locals. It's hard to leave food and people in hot car, walk down and back up hill, especially if you are in line at top of hill. I don't purchase tickets online, never buy a pass. No cell signal in line to buy, at times. People pull forward at bottom of row 2 or 3 and leave gaps all the time, because of where toll booth is. Please stop letting people fill gaps!! They must pull forward! Please! Huge problem... Ticket booth at top with clear directions would eliminate huge ongoing problems!

Possibly an extra ferry stop between 12:45pm and 3:15pm, not just on Fri/Sun.

Possibly more runs during heavy load times in addition to the Friday/Sunday summer schedule.

Prefer the old schedule where a trip to Ketron only happened when PCF was called. Would be nice if ticket takers asked people in line not to leave their vehicles running or play music loudly. Would have been better to install round-about during low season.

Put back the early afternoon run and eliminate the 10 pm run which has low ridership. The early afternoon run had higher volume and better meets our needs. Begin the two ferry service on weekends ion Memorial Day as June is really too busy for just one ferry

Put back the run that was taken out of the day to create the 10:20/10:50 pm run that only has 2 to 4 cars from Steilacoom and usually none from AI. Go back to the old schedule. The current schedule creates overloads on almost every run on both sides! The odd times and length between runs makes it very difficult to schedule appointments. Plus you always have to get in line an hour ahead at least to be sure to get on.

Put more boats on weekend days.

Response

Queueing in Steilacoom is out of hand and confusing. At busy times, the line extends through the neighboring community streets and affects folks' homes. When someone doesn't return to the lines before loading or if their car dies, the cars stuck behind them often get "cut off" by folks in the next lane who start loading without checking that there isn't a problem with the remainder of the lane before them - and the dock facilitators aren't doing a thing about it most of the time. One can arrive 90minutes before the next scheduled departure and still not make it on that ferry to the island. A 20-minute ferry ride goes from around a reasonable hour-long commitment to a 3-hour+ ordeal when not enough boats are in rotation (15min drive around Steilacoom figuring out where the end of the lanes actually are that day, 2.5hr wait in line if you want to be sure to make it on your intended ferry, then 45min to the other side including boarding and deboarding). This has been an issue during summe

Raise fares for a bigger ferry. Priority boarding for home owners. Scedualed ferry trips.

Read my last answer to question #10. We need more runs and better/ more efficient loading.

Really dislike the large gap after noon. I know the crew deserve a break. And a shift change does need to take place. But a 2 1/2 break in schedule is excessive. The double boats do help but is limited to certain days and availability of statff.

Really need 2 boats longer than two months scheduled in the summer on Thursday, Friday, Saturday and Sunday.

Reduce rates? (like that's gonna happen!)

Reduce taxpayer costs. If you use the ferry pay for the ferry. I have lived in WA for 45 years and have been on a ferry one time.

Reduce the number of runs to reduce the population of Anderson Island.

Reduce to one boat. Put a ticket booth at the top of the lane. Give priority ridership and discounts to full time residents. Stop encouraging so many visitors. They treat the island like it's their campground.

Reduced fare for full time residents! And using the second ferry more often.

Regular Schedule & 2 boats doing busy weekends

Reliability (constant breakdowns) of the boats & having a second boat when indicated on schedule.

Reliability, response to overloads, vastly improve communication, decrease the very long gap after the noon hour ferry, install a ticket booth to direct riders to the appropriate lane and enforce line-ups.

Remove gaps noon to 2

Response

Remove the mid day break Increase crew wages to prevent staffing issues

Replace the weekday late night run that no one uses with an additional midday run where hundreds of people a day are desperately stranded or waiting in line for hours. Don't allow RVs & boats on first 3 morning commuter runs. Pay more so you have enough staff to run 2 boats.

Require everyone on Ketron wanting the ferry to call in before the ferry leaves Steilacoom. That way they would know exactly how many car spaces to leave and could get more AI cars. If they didn't call in, they don't get on. Add the daytime ferry back in!!!! The over loads just to GET OFF the island daily are just crazy. You have to get to the ferry at least an hour ahead to get the ferry you need. The very last ferry of the day is NOT well used, usually only 2 to 3 cars from the Steilacoom side and none from AI. Especially in the fall and winter months. Is anyone tracking ridership on those runs? Keep it on Friday, Sat and Sun runs if needed, but to take away the daytime run for it during the week is ridiculous. Run 2 ferries! I've heard it is difficult keeping crew. Find out why that is and fix it. Money? Hours? Management? Thanks for letting us comment!

Return to the previous schedule. The 10:20/10:50 is a waste of time and money. Service for a handful of cars is no very cost effective. We need better timed runs during the morning and afternoon, not at night. Having to leave for an appointment two ferries ahead of said appointment is ridiculous. And that is only if one is at the ferry landing 60-90 minutes ahead of departure. Summertime is especially a nightmare.

Return trips to Steilacoom on Sundays are always a gamble on just how early I need to be in line. Demand for service is high while service is not adjusted for the high demand. There are just not enough runs to cover the traffic. Perhaps if there were better park and ride options on the mainland it would be easier to walk over without requiring a vehicle.

Routes along major commuter lines

Run a second ferry every weekend friday thru sunday. Add a couple more runs weekdays at peak hours. Or establish a priority line for island residents. We need to be able to get business done and to safely return home.

Run every hour.

Run extra boat for contractors as they are a cause for many overload situations.

Run ferries for peak service times. If running at less than 1/2 occupancy, then it is losing money. People elected to live on the islands. Let them pay higher fees to travel to and from the home THEY decided to live at on an island.

Run the 2 boat schedule every weekend

Run times and 2 boat operating on busy days cause over crowding is very common and people who reside on the island sometimes don't make it commuting from work and get left cause of no room. Everyone is looked at equal on the system but I wonder if there's anything you can do for people who live on the island like discount or memberships and accommodations for full time residents

Run two boats every weekend regardless of holidays at least during the summer.

Running double ferrys longer Possibly year round

Running every hour to accommodate buildings and subcontractors, using sun passes to pay for ferry tickets so you could get rid of office worker's Would load faster more efficient.

Running more during those days or having a larger ferry that can hold more cars

Running more than one boat more often. There has been a huge uptick all year round in Airbnb and VRBO rentals on the island and so only surveying home and property owners does not tell the whole story. These vacationers use the ferry more frequently than the majority of island residents as the majority turnover of guests happen every few days. The 4th of July weekend was a prime example of how off island vacationers can enormously swell the demand for ferry service. My husband and I waited in line 4+ hours in Steilacoom on Thursday, July 1st late afternoon, and 3+ hours on AI starting at 11:30am on Monday July 5th.

Running multiple boats around weekends during high traffic times would make it more predictable to catch a ferry, instead of waiting for hours.

Running second ferry more often on weekends. Especially on week days before and after holiday weekends or holidays.

Running the extra ferry (esp. summer) when the lines back up so far (ie some Thurs. etc) It has taken over 2 hrs. to load them Keep restrooms open and clean and crews should be watching this. The ferry announcements cannot be heard when in cars below. ***ENTERED FROM PAPER SUBMISSION***

Running two ferry's Thursday through Monday especially during spring summer and part of fall.

Runs every hour with no breaks or fuel runs only shit. Every hour the boat leaves one side, EVERY HOUR, NO GAPS OR DELAYS, that will allow people to leave at different times and not all be stuck on the same runs. Most people have a flexible schedule on the island but need to run errands etc. the noon boats are too full along with the 10am & 2:40pm and that just runs into rush hour times so it is always full. Get off your asses and come down and watch it every day for a week. You will realize quickly this is a shit show and could easily be operated more efficiently. Not looking for an extra run, just a schedule shift. Someone should look at the data and analyze the loads because it's been pretty consistent over the last few years, excluding 2020.

There is TOO MUCH CONSTRUCTION going on and all the trucks are causing full time islanders lots of delays and missed ferries. Limit the number of short-term rentals and monitor and tax them. If people are afraid of having fir trees in their backyard, then don't move here. The county needs to have a composting business on the island instead of builders having to take it all off island.

Snacks/refreshments available for purchase in both sides during peak wait times.

Some sort of residents first policy, and better communication of and more even enforcement of the existing rules.

Someone to monitor the lines on the busy weekends in the summer and to use the second boat that just sits there in a much more efficient manner this even if it runs a shorter shift to cover the obvious overflows. With the ne round about planned I am confused as how the huge backups will be handled and am sure the residents of Steilacoom will bet bitter as to the traffic mess that is coming!

Spacing the mid day run to Ketron more evenly between the only two other runs would be beneficial to us. Communication between Pierce Co. and Ketron island could be vastly improved. Currently, changes made last minute are poorly communicated, and rarely in a timely manner.

Spring summer scheduling and consistent staffing.

Staffing two boat service on weekends

Staffing. Ferry maintenance. Consistency. Ferry manager that listens.

Start two boat service earlier in the year. Start two boat service earlier in the day. Get your staffing under control. When they're short, they do a lousy job of loading the boats. Put the toll office at the top of the Steilacoom lanes. Enforce what rules you have for being in your car, no gaps, no cuts. Increase no commuter fairs relative to commuter fairs. Change the pricing tiers so 22ft pickups don't pay the same as a 14ft. car. When commercial vehicles reduce car trips due to weight, charge them for the weight, not length. Get your ferry maintenance under control. Find someone who understands the situation to do the scheduling of maintenance. There are so many ways that this is mismanaged.... This would be inexcusable in the private sector.

Starting Memorial Day weekend through Labor Day weekend there should be 2 boats, Thursday thru Tuesday. Traffic on Holiday weekends is growing every year.

Response

Stay the course! ***DIGITALLY ENTERED FROM PAPER***

Stay the course!!!!

Steilacoom to Anderson perhaps a snack or coffee stand?

Stop at Ketron before coming to AI in the morning run.

Stop cancelling the two boats. We pay extra for this service but yet still do not get it.

Stop catering so much to visitors and vacationers. The people that commute are your bread and butter. There are people driving on now that have to wait two and three ferries in the summer to get home. Devise a system that takes care of the islanders, not the mainlanders. Give us priority for boarding. You can do it, I know you can!!

Stop the continued run cancellations, squeeze more cars on instead of leaving so many cars behind, add more runs when you see that they are needed.

Strongly recommend a reliable two ferry system on Fridays and Sundays. Year round would be best.

Study the times where overflow are consistent and add a second ferry if financially appropriate.

Summer ferry lines have become difficult. Perhaps add a couple strategic two ferry runs, such as July 1st (thurs before 4th). The lines were just crazy long for those taking a long weekend.

Summer overflow/wait times are severe and appear to be trending worse. If there's any way to accommodate summer traffic, it certainly would be appreciated.

Summer overloads are problematic. As the population and popularity of the island continues to increase, additional ferry runs will be required.

Summer schedule should start Memorial Day not July 4th. Add 1:30pm ferry daily

Take long mid day break out

Take out ferry at times not much use and add it to when high need so not so long a wait....

That gaping hole mid day needs to be plugged, please.

The 2 1/2 hour gap in the middle of the day is ridiculous. It would be better to take the last boat off Monday-Thursday to give us another mid day run.

The 2.5 hour gap in departing in the afternoon is too long, the line gets filled up unless you get in line over an hour early!

Response

The 3 hr span between the 12:00 noon ferry and the 2:45 afternoon ferry. Also, The continual back up from there being an insufficient Boats running.

The 6:20 run is critical for working commuters. It would be very beneficial to not go to Ketron on that run.

The Long break between 12:10 and 2:45 is difficult on my schedule with family arriving and departing, and especially on errand day. It means that the 2:45 is almost always an overload, therefore you need to be in line over an hour early, or just plan on taking the 3:50. I appreciate the ferry very much, but an extra hour in line on both sides due to overloads is often burdensome.

The SCHEDULE! I haven't spoken to a single resident that feels the schedule makes any sense. The almost 3 hour gap in the middle of the day? It's inconvenient and in the summer, it increases the line backup. Which results in worse backup for the remainder of the day. Not loading the ferry. Multiple times there is room for at least 10 cars and the ferry leaves at least that many behind. The 2 ferries running needs to start with the vacationers, not the 4th of July. Does anyone record numbers?

The afternoon departure times from Anderson Island are not frequent enough, which causes overcrowding and long wait times. We (the Pierce County Library) have had to reduce library service hours in order to make the ferry back to Steilacoom. In addition to adding more afternoon runs, an improvement could be a reservation system.

The amount of crew turnover on the ferry is concerning, it seems like they're constantly training new people and can't get experienced crew members to stay. Possibly a pay issue? I feel like with more competitive pay scales they could keep experienced crew who would be committed to running a smooth and effective ferry service.

The amount of overflows that is getting to be more consistent. Either through revamping the schedule and adding runs between noon and 3 or increasing the times when double ferry's are used. Also to fix the staffing issue so runs don't get cancelled.

The amount of sailing on peak days (fridays and Sundays) as well as taking better care of the employees.

The attitude of the full time riders. That being said...it would be nice to have a discounted cost for senior commuter passes for full time residents.

The backups for the ferries have become routinely terrible. More ferry runs are needed. In addition, communication about cancelled ferry runs is inadequate. If something like that happens, it should be posted on every website and social media pertaining to the ferry.

The big gap between noon and the next ferry

The big gap between the 10:30, noon and 2:45 ferry on the Steilacoom side causes cars to stack up.

Response

The break midday creates backlogs on both sites. The weekend starts on Thursday now and the backup reflects it. I spent two hours in line each way trying to get to the Dr. please run the second boat on Thursdays.

The capacity for carrying people and cars is inadequate for Anderson Island's current population

The congestion on the ferry and having to wait multiple ferries is frustrating and creates a lot of bad blood amongst residents. First and foremost, the lunchtime break needs to be removed from the schedule (weekdays and weekends year-round) since that almost 3 hour break in service each day ripples through and creates a punch point that afternoon ferry service doesn't recover from on many days. Second - most cars are single drivers. Why isn't there a carpool incentive like the State ferries have (something like priority loading for registered carpools for the first 10 spaces on weekday commute times). Third - we need to address overnight parking availability and security on the Steilacoom side so that weekend guests can park and walk aboard instead. (Right now it's unclear if you can park overnight in the paid lot and that confusion means people don't do it.) Fourth - we need to find a way to encourage islanders to walk aboard and leave their car on the Steilacoom side for daily commu

The crew is awesome. There needs to be more boats Thursday, Friday, Saturday, and Sunday

The current waiting times are totally unacceptable. Two ferries needed every Friday and Sunday, not just hit and miss. Another auto loading ramp on Steilacoom loading side. More daily runs are absolutely necessary to shorten wait times especially between noon and 2:45. Two ferries should start with Peak rate season. ***ENTERED FROM PAPER SUBMISSION***

The ferry constitutes an extension of the Pierce County road system. Like it or not, that is what it is. Those of us who live on the island, pay our taxes for our roadways, deserve better access. 2 boat service should be provided on weekdays during the hours of 7:30 am to 6:30 pm. Islanders desperately need to be able to commute to work and to medical appointments. If you need to raise the fares to do so, then raise them. Whatever it takes to provide 2 boat service. Considering the rapidly exploding development on Anderson, our population will increase dramatically in the next few years. The current level of service is insufficient as it is with the frequent overloads, and it will become far worse in a year or so. We need 2 boat service on weekdays also.

The ferry has to allow for passengers working with the busy train crossing. We do not drive our cars for the convenience of walking on

The ferry is POPULAR and it can be very hard/stressful to get out to the island during the summer or at popular times. My father lives on the island so we're often trying to ride the ferry out for father's day or other key holidays and it can take a few boats to finally nab a spot.

The ferry line and ticket process

Response

The ferry management. It seems that there is not flexibility to meet demand and that is becomes normal to have overflows and leave people for long waits. The ferry needs more runs during busy times. The long gap in the middle of the day is a killer especially now that there is daily overflow

The ferry often leaves minutes early, which is very disappointing when you are rushing through traffic to catch the last boat. Ketron island is a private island, and should have their own private ferry service. The triangle runs to the island are a major inconvenience to the Anderson island community.

The ferry schedule doesn't work with the growth on the island. My families have lived on the island since the 1940s and this is the worst system I have seen. The permanent residents really can't determine the best time to do our chores in town. A better schedule would help. Not one that has hours between sailings. Double ferries from late May to early September on Fridays and Sundays.

The ferry schedule is horrible The break from 12:10 to 2:45 is not workable, it is always an overload There are more people on the island and just makes bigger mess, because the ferry can't accommodate it There is so much construction, we have to deal with the extra workers

The ferry schedule times for Ketron Island are extremely unsatisfactory and need to be improved.

The ferry schedule. Include the month of June to run double ferries. Include holidays as double ferries and not just weekends.

The ferry traffic has been insane these last few years and seems to be getting worse. Even during the off season we have an insane amount of consistent overloads, whereas that never used to be the case, except during holidays and during the summer. I don't much know how to fix it, but it would be great if we had a system in place that gave precedents to full time residents, those that own property, and their guests. The other issue I have is the lack of boundaries put in place for those that violate others. There's a man that lives on the island and is very aggressive in his language and inappropriately takes pictures of young girls when he's on the ferry. The ferry workers and their boss have done nothing to limit this mans access to the passenger deck, making it very uncomfortable and unsafe for those that have had encounters with him.

The frequency of runs during the summer months.

The frequency of the ferry runs, amount of ferry workers

The gap between 12:00 and 2:45 is too long.

The gap from the 12:45 and 3:15 that is two far apart

Response

The giant gap between 12 and 245 is problematic. Construction trucks should have to reserve space or pay for extra runs. The illusion of two boat service in the summer is actually only two days a week for 8 weeks (if they actually do it)—it should be Memorial Day through Labor Day AND on other major holidays. But they should not blindly be going back and forth, this should be responsive to actual demand. If the second boat isn't needed one hour, don't run it. If there are massive lines, pull it into service even if it's Thursday. Most importantly, we must recognize that the ferry is a polluter and more runs all the time are not the solution. We need to start prioritizing people vs cars, make transit more feasible, and we have to see if we can reduce the reasons people leave. I would like Amtrak to start stopping at the dock again coupled with a shuttle or taxi on the island. The bus to Lakewood Station should be times with ferries. I would love to see some positive devel

The holidays seem to be the biggest issue. If the ferry could run two ferries Thursday, Friday and then on Sunday and Monday that would certainly help. On regular days I know I have to be in line at least 45 minutes early if I don't want to miss the ferry due to overcrowding.

The hours long gap in the daytime is horrible! The 6:15 am boat going to Ketron is a terrible, terrible mistake. We need boats every hour. Having to wait three hours in the afternoon is absolutely horrendous. Waiting two us hours in the morning for the 12:45 is also horrendous.

The huge gap from 12:10-2:45 is AWFUL!!!! There needs to be one run during that time, as not enough time to get shopping and doctor visits (plural) done in time to get there at 11:10 to make sure I catch the 12:10. And to relieve the overloads on both sides as a result of waiting 2&3/4 hours in between ferries. Also, the commercial vehicles, for which WE ALL PAY INFLATED PRICES, also have to wait, which makes them lose the rest of the day--that's hugely costly.

The increased demand for the ferry make it very difficult to get to AI without experiencing an overload and waiting for another boat. Schedule needs to change to include a 2nd boat more often.

The lack of midday service is hard on islanders. Also, seems not enough 2 boat days, especially for summer. Seems to be getting longer wait times.

The lag between noon and 2pm. Have no personal need for the last late night ferry.

The line situation. It's atrocious. There needs to be more oversight and accountability. The ferry staff are essentially useless when enforcing the rules because they don't watch the line and they don't even have a clear understanding of the rules. The lines on the AI side are not monitored at all so there needs to be a complete overhaul of the ferry staging process that eliminates line cutting/jumping.

The line up lanes for the ferry could use some better organization and supervision. I think that newcomers and visitors find it confusing. We already know that holidays need two ferries, but I also think it would be a good idea to keep track of wait times this summer to see when the long waits are that could use a second ferry. I don't think it is a good idea to have two ferries all of the time. That would make the island too accessible and overcrowded.

Response

The lines are getting longer and earlier, growth does that. The schedule needs to be more often and both boats need to be used on a regular basis. We pay for both boats and I guess we are going to have to pay for two crews each day too. I know your job is difficult and the provider is not very consistent in their provisions of service. They told us today there would be no Sunday service because they can't hire enough people for the crew - make them pay more and they won't have that problem I understand.

The loading procedures seem to be inconsistent and random.

The long break between noon and 3

The long breaks between trips around the noon hour is problematic, especially in the summer when there are more riders.

The long gaps during the middle of the day

The long wait lines. Additional ferry's during peak times, Schedule certain times for large trucks, identify owners of property on the island for priority boarding(this could be done with a window sticker and designated lines)

The long wait times on weekends and holidays and construction crews

The morning commute runs could be improved

The number of runs between 10:05 and 3:50 PM. There just aren't enough. Or, we need a much larger boat, plus the Steilacoom II. The waiting time is incredible and getting worse. We've lived here 8 years and this situation is worse than ever. Will pay more for decent service. I spend over two weeks (in hours) annually waiting for a ferry. Try that some time - you won't like it. One time we gave up and went to a hotel in Dupont and returned the next morning to board.

The number of runs must be increased and 2 boat service for longer periods of time. Having 2 boats for a couple of months doesn't cut it

The old schedule that had a 6:15 am that didn't go to Ketron and that had a 5:30 pm leaving Steilacoom would let us stay on the island. The way the current times are spaced is good and the ferries run on time instead of always being late.

The order we load the ferry should be from the front row 1,2,3 the. Second row 4,5,6, ect. As other ferries in Washington do, rather than the current entire lane one followed by the entire lane 2, ect. Two boats should run the entire summer Starting in May or at least June. And every weekend day not just Friday and Sunday.

The overflow

Response

The pay for deck hands is terrible, which results in high employee turnover! The cancellation of the double boat schedule on Fridays and Sundays has gotten out of control! My question is what if any monetary penalty does the contractor pay for not operating a full schedule? Reinstate the cancelled ferry runs!

The people are great!

The recently posted an accounting of the days, times, and number of days the left cars behind. It looks like a repetitive pattern. Could be an example of how to plan a multiple ferry schedule!

The roundabout they are installing is a joke. Worst place to put it. Already seeing the fallout from it. Think it is wasted tax payer dollars. There are other solutions that would have been more satisfying for tax paying steilacoom residents and island residents. What a debacle... Providing more parking for walk over would have been a better solution. Just my 2 cents...

The rudeness of the ferry crew, some of them. Full timers need priority access, visitors/vacationers second priority. This waiting for two or three ferries with a car full of groceries is not fun.

The schedule

The schedule for weekend and holiday spill over especially during the good weather periods has been insufficient to keep up with demand. The overflow access and layout is below average at best.

The schedule gaps in mid day create horrible scheduling issues and long waits. Allowing LeMay or other trucks on the commuter runs is wrong. Double boats prior to and during busy summer weekends needs to expand.

The schedule is not designed for people who commute daily, rather, it accommodates retirees. I am not confident that it is meeting the needs of students, though that was given as a reason for the changes. We homeschool, so that aspect is not as relevant to us. We have been full-time for five years and are now selling and moving off island due to the ferry schedule. The 2020 schedule changes mean that my spouse must leave on the 5:15 to arrive at work in Tacoma by 7:30 am due to the Ketron stop on the 6:20 am. He now cannot get back on island until the 6:10, which means he arrives home shortly before 7 pm. He used to take the 6:15 am and the 5:30 pm.

The schedule need an upheaval

Response

The schedule needs to be expanded. The long gaps between some runs cause unnecessary back-ups. The many mechanical issues causing service cancellations is not acceptable. More people are full timers who need access to the mainland for work and medical appointments. It isn't reasonable to have a three boat wait to get home from work on a Friday night. As part timers, we pay the same taxes that full timers do, but getting onto the island is becoming increasingly difficult. I-5 traffic is another issue! Considering the needs of everyone, I really think service should be expanded, either with a larger ferry or a 2 boat schedule. I'm not saying I should never have to wait for a ferry, just that there should be improvements.

The schedule needs to change and remove the middle of the day gap. Every day ferry takes several afternoon runs to recover from missing service at ~1:20 PM. The 2:45 PM run is always overloaded, and overloads continue from that point.

The schedule your team is very good and it's always clean you can run a little better but that's okay

The schedule, especially in the afternoon between 2:45 and 5 PM

The schedule, the customer service aspect, communications would help.

The schedule. Need to run two boats every day. Every afternoon.

The schedule. The gap in the middle of the day when more people need the service needs to be eliminated. The crew. Seen too many empty spaces at the back of the ferry due to poor loading.

The schedule. We need a second boat more than two days a week for two months of the year. The gaps during mid-day cause massive frustration for the boats before and after the gaps. We are moving off island because we are tired of the ferry and having to show up so early to ensure we can catch the boat. Also, we would have a child that would have to take the ferry for school next year and I can't believe the 1 1/2 hour commute those kids have each way. There should be a priority boarding option for residents first, then part-time owners, vacationers, and lastly day-trippers. Or just use that second boat and improve the schedule!

The second boat should be used more, as soon as we start paying the higher summer rates we should also receive more ferry runs to help with overloads. We need someone stationed at the top of the lanes constantly forcing people to pull forward all the way to not leave gaps and also to not start another lane until the previous one is full.

The signage on the Steilacoom side, a final clarification on "filling gaps," and most importantly more ferry runs!!!! Or alternative travel/ferrying for large construction-sized vehicles.

The stretch between ferries in the afternoon seems to increase the overloads for the rest of the day during weekdays.

Response

The students attending Pioneer Middle School do not get to school on-time. Would be interested in seeing if the 7:30 ferry time could be adjusted.

The summer 2 boat schedule should be maintained as it was intended. To account for increased traffic. Instead it is being used strictly on holiday weekends.

The time between the 12 and 2:45 is too long. The ferry is too small. Perhaps two runs at 12 and 5:30 on Thursday thru Sunday all summer.

The time between the 12:45 pm runs and the 3:15 pm runs. Too long of a delay. The Island is getting busier because of more people moving here. We'll need to add a run here and there to provide acceptable service.

The time between the ferry runs, starts too early, too much time between the 11:30am and the last ferry. Starts too early for service providers that need to be here more than 3 hours per day, and ends too late. The ferry does not address working hours. Most service providers will not come to the Ketrone due to limited ferry service.

The time required to access the ferry has doubled for drive-on trips because of the variability of demand and fewer sailings. People need to be at the line 45 min before morning sailings to be guaranteed a place, an hour for return trips in the afternoon. Time spent waiting on the ferry after loading has also doubled as the lay-times are excessive with the current schedule, and the crew takes several minutes sending down cars one at a time. Crews are not encouraged to be time-thrifty, and are increasingly only short-term and inexperienced employees.

The times of runs and not running two ferries

The timing of the boats

The traffic when unloading ferries in prime hours of the day is a nightmare please start by completing the roundabout at Dune

The two hour and 35 minute gap in the middle of the day causes all afternoon ferries to back up and overload. We need an additional run in between these ferries.

The use of a second ferry is very needed for those demanding runs. Friday afternoon, Sunday afternoon and holiday when the second ferry is needed.

The wait time in line, the control over the line up problem and the long gap between the 12:10 and 2:45 p.m boats.

The wait times are terrible. You have to be in line at least 1 hour before the ferry. The gap between the 12:10 and the 2:45 is unbelievable. There needs to be a double ferry during the morning and afternoon runs. There also needs to be 2 workers in the ferry line to control the crowding. Probably living in a dream world, but this ferry system has to change. It is only going to get worse.

Response

The way they load the ferry.

The whole system needs revamping. Not much of a service when it can take up to 5 hours to run and get a prescription or keep an appointment or just for anything off island.

There are 2 huge gaps in the schedule in the middle of the day. That causes a lot of problems. You need to run more runs during that time. Dominic acts like a jerk and threatens riders and yells at people. The ferry is dirty. We only get 8 weekends with 2 ferries, yet 50% are canceled. How are residents supposed to deal with the influx of people and do things like go grocery shopping? The lady in the office, with white hair is very rude and has no customer service skills. The employees are racist. Hendrick quit because of it. Berry followed him around. Shameful!! The people in the office knew about it. The residents should have preferential loading at certain times.

There are a lot of times that are know. In advance that the ferry will be above max capacity. A two ferry system should be employed more often. I also remember a time they used to marshal the cars in much better with small gaps between cars to make sure they took everyone they could. Generally, i see 5+ car space on the ferry with cars waiting that don't get on. I also see small cars behind a bug truck in line and they can't take the truck so they don't take the car behind him. They should look to do that.

There are backups that occur at certain times of the day and sometimes we are left behind to wait for the next ferry. Maybe a slight increase of 2 boat service at those times.

There are runs I have been on that the workers could have gotten more cars on, but did not load properly or move cars up tight. Training issues? Remove the 10:20/10:50 pm run during the week and put it back in during the day. This has contributed to the major overloads ever since the schedule was changed. The times the ferry runs has made scheduling appointments very difficult, especially the morning runs. The last schedule was so much better. The extra time between ferries hasn't seemed to help delays, and the huge gap between the 12:10 and the 2:45 from Steilacoom is very frustrating and make the 2:45 almost impossible to catch unless you show up an hour and a half early. I have attended the ferry meetings in the past, but even after voicing opinions the county just seems to do what it wants. So I quit going. Thanks for asking! Best of luck.

There are times when it is unpredictable how many spots Ketron gets to reserve, they should NOT be given preferential treatment. We don't even have a chance to park and walk on because we don't know we will be missing it with where we are in line.

There could be more boat service in the summer. They currently run two boats starting with the July 4th weekend through labor day on Fridays and Sundays to handle increased flow but we really could use that service on Thursdays as well during that time. There is a large afternoon gap daily between 12pm and 2:45 that could be filled as a vehicle overflow is common during that time.

There is a very long midday block with no ferries. Ferry use is outstripping the current schedule. We've had a very high number of overloads this spring and summer; more runs or more boats or a bigger boat?

Response

There is too much of a gap between the 12:45 and 3:15 ferries.

There needs to be at least one additional run to Ketron in the afternoon, maybe leaving Steilacoom at 3:30? Please return the late ferry run to Ketron on the weekends. We can't possibly attend an event, enjoy a night out, without having that run to return to the island late.

There needs to be a ferry run in the afternoon to eliminate the huge gap they take for lunch which always results in a multiple ferry overflow. There needs to be two ferry services all day in the summers and around holidays.

There needs to be a ticket booth or a ticket taker at the top of the lanes who can also direct traffic into the proper lane and remind people to pull all the way forward and not leave too large of a gap between vehicles. There also needs to be someone directing traffic on island during major overload holidays. The overflow line on island is extremely dangerous and someone will get killed if it stays the same as it is now.

There needs to be accountability in the ferry staging areas to keep people honest as to who came first. Need consistency with what is allowed and what is not as far as cars in line, filling gaps, parking on crosswalks/ or not. Tickets should be scanned at top of line (automated scanner?) as we arrive and staff should be present to direct where each new arrival should go. Commuters should have some sort of priority and not have to wait through 3 or 4 ferries just to get home from work when the holiday traffic takes over. Need more than 1 person on busy holidays to direct traffic. On Thurs before 4th of July, I approached Steilacoom staging area, I honestly assessed what we lovingly call the 'shit show,' and decided to proceed down into lane 3 which was half full. There was no one there to direct me or anything that indicated that I should not proceed into lane 3. A few minutes later an attendant came and told me I had to back all the way up and go park on the side street. I had no idea.

There needs to be more double ferries from Memorial Day to Labor Day - afternoons Thursday through Sunday. You have the data - use it to make decisions!

There needs to be more runs. More boats. A larger boat. More frequent runs. Runs overnight. Address the fact that school kids are on the bus for 90 minutes each way, as young as 9 and 10 years old. That's unacceptable.

There needs to be more viable options for parking in Steilacoom for commuters; it would be great if the county could find a way to purchase or lease land that could be used for parking possibly including a parking garage at rates affordable to commuters. This would open up the potential for a passenger-only ferry, for example. The funding could be made available through TIF funds or similar/additional fees on development on the island, which will continue to stress the ferry system even more going forward. The lanes and ticketing system needs a better way to prevent lane cutting including a ticket office at the top of the line. More double runs including on Saturdays and certain Thursdays i.e. before holiday weekends. Charge more for single use tickets but don't charge more for commuters.

Response

There needs to be two ferries running at peak times in the morning and the afternoons. We go to town for doctors appointments for my child and for a single one hour appointment we are away from home for upwards of 6.5 - 8 hours due to the breaks in the ferry runs, the overloads and the traffic. This is unacceptable. When it's summer, 90+ degrees and we have to wait for the ferry three hours to get home it's quite frustrating to know that this could be prevented by adding a two boat service at key times throughout the day. I can't attend the AICAB meetings because I am a solo parent to a child that has a compromised immune system. I can't get to them so I can't speak about my frustration. Last week after being in the hot car for 1.5 hours my kid broke down screaming upset. There needs to be an option for residents to have priority over part time visitors or have some kind of reservation system so that we can reserve a spot on a specific ferry and know that we will get on and get right

There seems to be a lot of construction equipment taking up a lot of space on the ferry during the week. Nit sure what can be done about it, but maybe having Pierce County stockpile road materials during the slow season so they don't take up prime space all week long.

They need to close up the huge gaps between 10:30-2:45. They need more double ferry shifts during overload times. It is very frustrating to wait 2+ hours for a ferry due to either the gaps or the overload problem.

They need to follow through with their double schedule when they say they will, and maybe expand it to more days.

They reduced the number of runs about 2 years ago. There's a consistent overflow on weekends due to this schedule change.

This is a fairly unique service for a state to provide! Good publicity,generous budget - this is essential for those who live there, commute often, have fabulous vacation site(s) and options.

This is something I have been fighting for long the way the ferry is run. People of Anderson island believe that the people that run the ferry just don't care about the people of Anderson Island and I agree .Bigger Boat

Those that are ADA qualified find it hard to get to the pay booth if at the end of the line. The hill is hard to climb back up.

Thurs, Fri, and Sundays - 1p - 7p, two ferries should run (summer only). Also, if there is a large project, the gravel and concrete trucks should be required to charter a ferry. When only 1.1 lines can load due to weight, that really impacts those od us that work on the mainland.

Ticket booth at top of lane lines Running both ferries during peak times throughout the week not just summer weekends and holidays Fuel run not in middle of the day

Response

Ticket office at the top of the ferry lines in Steilacoom. Also it's not right to have Ketron allowed to call ahead and reserve space. Ketron provides the least income for the ferry, and gets the best service. I want to be able to call ahead and reserve my space. Additionally Ketron runs take the least amount of time on the ferry forcing the majority of riders and users from Anderson Island to sit in the vehicles and freeze in winter and boil in summer. This is not right on many levels. They cater to the minority and leave the majority hanging

Times

Times and more attention to two boats. For instance this 4th weekend they did a fuel run during the busy time. Our ferries were full from Thursday through Monday but only a little bit of two boat ferry. On the AI side, cars were on the wrong side of the road for overflow. A booth at the top or someone who actually helped get cars in lanes on Steilacoom side would help

Times are excellent but just need frequently. Double ferries all the time would benefit all.

Times during the middle of the day. Use of 2 ferries Fridays and Sundays through the summer.

Timing, frequency, availability.

To have a few ferry's more.

Too big of a gap from 12:10 - 2:45 results in constant afternoon overloads.

To increase ferry service during peak days/times

Too long between the noon and 2:45 ferry. Had or impossible to catch up with that much lag time.

Too many ferry runs are cancelled ahead of time....almost every weekend day in July the scheduled two ferry days have been cancelled. Also too many large gaps during the regular day schedule cause major backups all day long.

Treating Ketron Island residents equally and fairly. I've been visiting Ketron for 20 years. I have family that have permanent residents for 20 years and with the current schedule it's almost impossible to have a job on the mainland or any kind of social schedule with how the ferry schedule has been butchered. The only way for Ketron to grow or be serviceable is with a more equitable schedule.

Twice per day ferries and another ferry midday would do the community a lot of good.

Two boat runs June to Sept - everyday!

Two boat schedule needs to start earlier in the morning.

Two boat service Fridays and Sundays and holidays from Memorial Day through Labor Day.

Response

Two boat service during peak times.

Two boat service on Fridays/Sundays (or leading into, out of holiday weekends) from Memorial Day weekend to Labor Day weekend would improve our ferry experience tremendously since we use the ferry the most in the Summer time. That said, we've seen many Fridays that were super busy and had to wait for multiple ferries throughout the rest of the year too. Looking at the overall trends and potentially planning more two-boat service on Fridays, from Noon - 9pm, during the "off peak" months would be super helpful to reduce the congestion and long, long wait times. Two boat service during the summer should be all day, or at least from 8 or 9am to the end of service for the day to ensure that less cars are left behind and all that are trying to get to/from the island are accommodated. We would live full time on the island, but we have a middle-schooler who plays sports, so living on the island would make it impossible for our child to participate in the sports they enjoy most. (Not t

Two boat service when utilization indicates the need.

Two boats !!! When the elevator breaks down it needs to be fixed matched quicker. I am disabled and it's very hard for me when the elevator is not in service when I'm walking on the ferry

Two boats Thursday n Friday evening all year. We need parking on Steilacoom side. Or a Train Station to ride train

Two boats during summer and a boat between noon and 245.

Two boats on Fridays thru Sundays & Holidays.

Two boats running Friday, Saturday and Sunday from Memorial Weekend through Labor Day Weekend.

Two boats scheduled Friday-Monday in the Summer months. May-September. Increasing the rates to compensate would be acceptable. Large construction vehicles....can they be put in a barge? In the Summer these trucks dominate the ferry loads.

Two boats. Significant growth of single family homes, dramatic increase of STRs and tourists.

Two ferries

Two ferries all week all summer or separate times for residents versus weekenders or vacationers.

Two ferries during normal commuter times and maybe a ferry run during fuel stops during the day, Always causes backup.

Two ferries during summer as promised. Proper staffing. No breaks from noon to 3.

Response

Two ferries from May 1 or 31 (look at data) through Labor Day. End the long period in the middle of the day as it is hard to plan for that and it is a very long gap which leaves the first afternoon run enormously over-crowded and people have to wait a long time. Separate early morning and late afternoon ferry run for construction, DOT and other huge vehicles that work all day

Two ferries on regularly busy runs

Two ferries running to avoid horrible wait times, congestion and overload. No 2 hour no ferry times in afternoon. Runs every hour

Two ferries the day after a holiday. Start 2 ferry service 1 June.

Two ferries, working elevator for us handicapped individuals. Urgent passes for older people so they don't have to wait 2-3 hours in line due health issues.

Two ferry service during peak runs.

Two ferry service for all or most of the days/times. Planning for a larger ferry ASAP.

Two things: 1. Add back in the mid-day ferry run. Having nearly a 2 hour lay-over causes unnecessary daily overloads 2. To reduce ferry lane controversies, consider modeling the ticket sales and ferry lane management after the Point Defiance terminal.

Typically I wait anywhere from 4-8 hours to take the ferry to Anderson or back to steilacoom. Anderson is where we wanted to make our permanent home however we can't due to the lack of access between steilacoom and Anderson. Waiting hours upon hours not only on weekends (which is expected) but during weekdays as well, we have had to keep our Tacoma property. The ferry is not dependable. The ferry employees turnaround rate is exponential. The new staff have not been trained properly on how to load and unload cars. Pierce County has either forgotten or chooses not to invest in our only mode of transportation to our home.

Understand the shift change in the afternoon but the waiting time is to long. Need a priority board for permanent residence.

Use both ferries.

Use both ferry's at least during the busiest time of the day which is morning and afternoon

Use of double boat during summer and fix the schedule. Afternoon commutes to the island are horrible.

Use of two ferries at peak times when cars/trucks are left behind

Use two boat all the time for overload.

Response

Use two boat service during predictably high volume more consistently. Proved more information about overflow.

Use two boats more often at peak times.

Use two ferries daily.....tired of having to get to the ferry line at least 45 minutes early before scheduled time

Using 2 ferries more often. I wouldn't mind higher prices if wait times could be shorter.

Using both ferries Memorial day thru Labor Day....and then on weekends the rest of the year.

Utilize two boat during the week. Slim down the mid day schedule gap that jist overloads through the commuter times into the late evening

Utilizing two boats more than just Fridays and Sundays, especially leading up to big holiday weekends. I just visited my vacation cabin over the 4th. I waited over two hours on a Thursday night to get a ferry. They had to have an extra run because there were so many cars. This was after 7:30 pm. Monday getting off the island was a nightmare. Also, need more people helping those people unfamiliar with the ferry loading and lane structures. A lot of unnecessary confusion.

We absolutely need more runs. On a regular basis. I would also recommend limiting the growth of the island both of the island. If we don't have the infrastructure we don't have the infrastructure to safely safely increase the amount of houses that we should the amount of houses then we should stop allowing that to happen

Response

We desperately need more runs. Summer and holiday traffic is a joke. The increase in island population makes the ferry lines too long. I oftentimes miss a ferry run due to overcrowding. We need 2 ferries running

We don't use the system everyday, but there seems to be certain times that are beyond reasonable wait times, an issue that may be solved by some type of on-call second ferry?

We go to ketron often to visit friends. It is difficult to find a day that we can commit 9 hours to visit though because of the few ferry times. There have been a few homes for sale on ketron that we were interested in purchasing, because we really love the island, but ultimately decided not to because there was not enough ferry stops and we have school age children who would be tied to the ferry schedule too.

We need a bigger ferry. Add a ferry run from Steilacoom between 12:10 and 2:45. Two boat service is great if it happens. ***DIGITALLY ENTERED FROM PAPER***

We need a ferry between the 12:10 and 2:45. The large gap creates overloads throughout the day.

We need another run between the noon and afternoon service.

We need another run in the middle of the day and extra runs on the weekend.

We need continuous service without the fuel runs and long break preceding the 2:40pm run. Need continuous runs that follow a predictable schedule such as once per hour on the hour/half hour.

We need more runs!!

We need to run two ferries more often. A barge to bring over large trucks might be helpful. An additional run between 12:15 and 2:45 would also be good.

We now wait at least one hour in the heat of the day waiting for ferry. Mid day service is crippled. If one is overloaded, one has to wait for two hours , or more just to get in.

We see no need for the latest ferries every night of the week. We'd rather see an extra ferry between noon and 3, and maybe just have late night ferries Thursday, Friday and Sunday nights.

We use the ferry once or twice a month (RT) - and it has become increasingly difficult. Often need to wait more than two hours due to long lines. This must be particularly difficult for those who live on the Island full-time. Need to use 2 ferries at peak hours.

Weekend ferries, how staff load the ferries, they are no consistent, some staff leave big spaces in between cars on ferry Line cutting needs to be addressed better and the ticket takers including law enforcement need to be on the same page on this

Response

Weekend service and summer service really needs 2 boats way more often. We are jam packed from mid may though late Sept. 2 months of extra boats are not nearly enough.

Weekends and Holidays the Last Ferry from Anderson Island at 11:00 pm or 2300

Weekends seem to be flooded with visitors and the ferries overrun.

Weekly service runs to Ketron that would provide a 90min window for deliveries and estimates by service providers. A weekly 4 hour window for delivery of service within normal business hours for longer service i.e. HVAC, plumbing, electrical work. Current schedule forces overtime charges! Direct runs to Ketron that do not add 1hour to transit after a long day off island 06:45 departure, 20:30 return 14 hours?.

Whenever I go out or my sons go out to help with the house and property the ferry is always overcrowded with island owners trying to get off the island or come back. Like I said before two ferries should be running at least on the weekends, Friday, Saturday and Sunday.

Wish ferry would certify for gasoline containers (WSP is certified) If the schedule changes again - I wish more island resident and businesses were consulted. The last change was disruptive to the Island Propane fuel run and it took the vendor a few months to accommodate the change.

With island population increasing and amount of service vehicles going to the island, especially construction increasing longer ferry lines are common. During the times we have come to the island we can no longer arrive half an hr. To 3/4 hour early to make the next ferry. We usually have to wait for the next one after that . This is a big problem for full-time islanders as well. The most obvious and cost effective solution is to run 2 boats more often.

With the current population of the island I think 2 boats everyday all summer long and the rest of the year maybe 2 boats for commuting times.

With the increase in construction, the large gravel trucks and heavier equipment riders should need to schedule their trips just as Ketron people have to notify for a pickup. Residents of the island should not be left behind because more than one truck causes excess weight. What is all this heavy equipment doing to the life of our ferries?

With the increased construction and commercial ferry use at least one weekday (non including peak period weekend runs) should include a two ferry schedule. Peak (two ferry) weekend runs should include Sunday as well as Monday (if the holiday is celebrated on Monday).

Worried about the impact on Steilacoom traffic.

Would be great to have a priority lane for residents - especially on the weekends when it's extremely busy.

Response

Would like to see two ferry service expanded during the summer to include Thursdays and Mondays (non-holidays). Thursday & Monday ferries are often very busy with a multi-ferry wait. I often hear about AI full time residents push for priority for them which I do NOT agree as they pay the same as others for supporting the ferry. They chose to live on the island full time and dealing with the ferry is part of that decision. Seeing second ferry not running due to staffing shortages is frustrating. Seems like the elevator and restrooms are often out of service on the ferries. Bigger ferries in the near future would help. Lots of people moving to AI full time and more building of second homes is putting pressure on the ferry service. Waiting until 2050 or so for new ferries is too long of a wait. Seems like lots of issues with lane management also. Too big if a kunch break in the middle of the day.

You could definitely add another ferry during the long gap 12-3 during the day and pay ferry workers more so there will not be a constant turnover

You guys need to have your employees respect the islander. Very unprofessional staff rude and lazy

You should run 2 ferry's from May to the Labor Day weekend from Thursday thru Monday. You need to have a new contract with a better firm than Hornblower!

Your question # 6 needs to have none as a answer.

a extra ferry run between the 2:45 & 3:50 Take away a few late runs in week nite evening, maybe bigger gap in runs so still get home just later. Start 2 ferry service memorial day weekend when the island starts the summer vacation crowd. Stop at Ketron BEFORE ferry goes to AI. And it shows. From the top down. More consistency with employee knowledge of how things are done.
