Batches of 150+ ballots



Random check of selected batches requested by parties

November 2, 2021

The major political parties are encouraged to continue to request audits of the Pierce County tabulation system.

These post-election audits are authorized under RCW 29A.60.170.

The purpose of the audit is to compare a manual count of ballots to the machine count for randomly selected batches.

Random Audits – The Clear Ballot System

- With the Clear Ballot system all batches that have been scanned and resolved will be available as part of the audit.
- Ballot scanning and resolution will be stopped during the random check.
- One batch from each scanner (used in the election) will be audited.
- Batches will be chosen at random.
- The batch will be checked, to see if any of the ballots in the batch, for the race to be audited, were manually resolved.
- The original ballots will then be hand counted.
- Results from the hand count will be compared to the results of the machine count for the batch.
- Should results not match; a visual scan of the ballots will be performed to identify a possible reason for the discrepancy. Ballots requiring additional resolution will be processed.
- Audit findings and any actions taken will be reported to the Canvassing Board.
