## **Pierce County Sheriff's Department Officer Involved Shooting 1/27/2022**

**PCFIT Activated for Officer Involved Shooting  
Pierce County, WA January 27th 2022:**

On 1-27-22, at 5:47PM, a call came out for a suspicious subject in a vehicle in the parking lot of O'Reilly's Auto Parts located in the 14900 block of Pacific Avenue. Deputies arrived on the call at 5:51PM.

Deputies contacted the subject in the vehicle and radioed shots were fired at 5:56PM. Deputies rendered aid to the suspect and he was transported to the hospital. The suspect later died at the hospital. One deputy received minor injuries not related to gunfire.

An investigation into the officer involved shooting was initiated by the Pierce County Force Investigation Team (PCFIT). Further details on the officer involved shooting will be released as they become available.

Investigators have reviewed six different video perspectives, analyzed witness statements and forensic evidence regarding the shooting involving three Pierce County Sheriff's Deputies on January 27th. Based on the totality of the investigation, the circumstances leading up to the shooting are as follows:

**For Immediate Release 1:00 p.m. PST, June 2, 2022**

On January 27, 2022, at 5:47 pm, three Deputies responded to a 911 call of a subject slumped in a parked minivan in front of a business in the 14900 block of Pacific Ave South. Upon arrival they contacted 39-year old Jerome Holman.

Minutes into the contact a fellow deputy suspected the van Mr. Holman was in possession of may be stolen. This was based on the fact the two license plates on the van did not match the Vehicle Identification Number (VIN), although they appeared to be the same make and model.

Mr. Holman, who had initially opened the driver's door, attempted to close it while starting the van. Deputies feared Mr. Holman was going to attempt to flee and the deputy attempted to physically stop him from driving away. Mr. Holman accelerated in reverse, striking the deputy with the open door with enough force to drag and throw him to the ground a distance of approximately thirty feet. Mr. Holman then executed a high speed u-turn, narrowly missing the downed deputy and subsequently collided with a marked Pierce County Sheriff's patrol vehicle. He then positioned his vehicle in such a way, that had he accelerated, the deputies were at risk of being struck. It was at this point the involved deputy fired six times from his department issued handgun, striking Mr. Holman five times.

Investigators have learned the license plates on the van in possession of Mr. Holman had been switched and belonged to a similar type of vehicle, but had not been reported stolen. Investigators are working to determine the identity of the registered owner.

In the following weeks, the entire investigation will be formally presented to the Pierce County Prosecutor's Office for review.
