Officer Involved Shooting

Tactical Response Team members from Fife, Bonney Lake and Puyallup Police Departments were involved in a shooting while performing a welfare check for a 31-year-old male at a residence in the 500 block of Valley Avenue NE. A 34-year-old female suffered non-life-threatening injuries and was transported to a local hospital. No officers were injured. In a subsequent search of the residence, officers located the male deceased in a bedroom.

- Officer Eric Alfano, a 42-year-old male who has been with the Bonney Lake Police Department for 13 years.
- Officer Ryan Micenko, a 38-year-old male who has been with the Fife Police Department for 14 years.
- Officer Andrew Bond, a 32-year-old male who has been with the Puyallup Police Department for 9 years.
- Officer Patrick Thomson, a 32-year-old male who has been with the Puyallup Police Department for 2 years.

The investigation is active and ongoing.

Puyallup, WA. June 18, 2021:

The Pierce County Medical Examiner's Office has identified the 31-year-old male as Nicholas Bunten and ruled his manner of death as homicide.

The 34-year-old female was booked into the Pierce County Jail for Second Degree Murder.

The investigation is ongoing.

Puyallup, WA. June 8, 2021:

On June 7, 2021 at 9:47 p.m., the Pierce County Force Investigation Team was called out to the 500 block of Valley Avenue NE for an officer involved shooting.

At 8:50 p.m., Tactical Response Team members from Fife, Bonney Lake and Puyallup police departments had responded to the residence at the request of Puyallup police officers who were doing a welfare check of a male who had not been heard from by family members since the day before. Negotiators were speaking with the wife of the male when she came outside with a weapon and shots were fired.

The 34-year-old female was immediately rendered medical aid and transported to a local hospital for non-life threatening injuries.

No officers were injured.

In a subsequent search of the residence, officers located the 31-year-old male resident deceased in a bedroom.

The investigation into the use of deadly force and the homicide is ongoing and will be conducted by the Pierce County Force Investigation Team.
