11 **A Resolution of the Pierce County Council Calling for the Election of a**
12 **Twenty-One Member Charter Review Commission During the**
13 **2015 Primary and General Elections, Pursuant to Article 8 of**
14 **the Pierce County Charter.**

16 **Whereas**, Section 8.20 of the Pierce County Charter (Charter) provides that the
17 Pierce County Council shall cause an election of a Charter Review Commission in not
18 less than four and not more than six years after the May 1, 1981, effective date of the
19 Charter, and thereafter at least every ten years; and
20

21 **Whereas**, in Ordinance No. 85-101, passed on July 9, 1985, the Pierce County
22 Council called for the election of a 21-member Charter Review Commission in the
23 Primary and General Elections of 1986, and that Commission was duly elected and
24 fulfilled the requirements of the Charter; and
25

26 **Whereas**, in Ordinance No. 95-20, passed on March 21, 1995, the Council called
27 for an election of a Charter Review Commission. That Commission was duly elected
28 and fulfilled the requirements of the Charter; and
29

30 **Whereas**, in Resolution No. R2005-64, adopted on May 17, 2005, the Council
31 called for an election of a Charter Review Commission. That Commission was duly
32 elected and fulfilled the requirements of the Charter; and

34 **Whereas**, pursuant to the requirements of Section 8.20 of the Charter and in
35 furtherance of the public interest of the people of Pierce County, the Council hereby
36 initiates the election of a Charter Review Commission, to be elected at the 2015 Primary
37 and General Elections, fulfilling the requirements of the Charter; **Now Therefore**,

39 **BE IT RESOLVED by the Council of Pierce County:**

1 Section 1. The Council hereby calls for the election of a 21-member Charter
2 Review Commission at the 2015 Primary and General Elections in Pierce County in
3 accordance with the provisions of Section 8.20 of the Charter and with general election
4 law.

6 Section 2. The Clerk of the Council shall provide a copy of this Resolution, as
7 adopted by the Council, to the County Executive, the County Auditor, and the Director of
8 the Budget and Finance Department.
