Pierce County Community Connections is making the Substantial Amendment to the 2013, 2014, and 2015 One Year Action Plan available for public review and comment for 30 days from October 30, 2015 through December 2, 2015. ### Information about the 2013, 2014, and 2015 One Year Action Plan Substantial Amendment

- In program years 2013, 2014, and 2015, the Community Development Corporation (CDC) was awarded CDBG funds (amounts below in table) to carry out HOME Services activities. These activities have been cancelled and the CDBG funds will be reprogrammed to the CDC to recapitalize the CDBG Housing Revolving Loan Fund (RLF) program in the amount of \$412,414 for housing rehabilitation owned by low-income homeowners and for Rehabilitation Administration in the amount of \$175,000, for a total combined award of \$587,414.

- The amendment will also allow the CDC to be awarded FY 2015 CDBG Administration funds in the amount of \$70,000, which may include a portion of CDBG Administration funds generated from CDBG Program Income (loan repayments) from the RLF.
- The 2015 One Year Action Plan was prepared and submitted to HUD absent the proposed project listing for ESG. This substantial amendment includes the proposed project listings for ESG and any changes made to the 2015 One Year Action Plan as related to ESG.
