The information furnished with this application is true and correct to the best of my knowledge in accordance with the Pierce County Zoning Code, Section 18A.38.050 D., and to wit:

- a) The person residing in the temporary unit is a parent or close family relative who by reason of age or physical disability, is otherwise incapable of caring for him/herself; and
- b) The property owner understands and agrees to abide by the standards and conditions set forth in the Pierce County Zoning Code and International Building Code for a temporary housing unit and shall continue to abide by such as long as the temporary housing unit remains on the subject property; and
- c) The placement and use of the temporary housing unit or the property intended does not violate any applicable covenant or deed restrictions; and
- d) The temporary housing unit shall be removed from the subject property not later than thirty (30) days from the date the temporary permit expires or occupancy by the above listed person(s) ceases unless renewal of the permit (under the same provisions) has been applied for and granted; and
- e) When obtaining a renewal, the Building Official shall confirm by affidavit from the applicant that the requirements specified herein are satisfied. Application for renewals must be made 60 days before the expiration of the current permit. Renewals of said permits shall be automatically granted if the applicant is in compliance with the provisions herein and no notice of such renewal is required.
