- 1. Parties wishing to serve alcohol may do so only if the alcohol is served by a LICENSED CATERER OR BARTENDER with a current liquor liability insurance coverage. ... Initial _____
2. NO kegs or champagne fountains will be allowed. All alcoholic beverages must be served in a glass or cup by the caterer or bartender. ... Initial _____
3. Alcoholic beverages must be consumed only in the specific room or building. Initial _____
4. "BYOB" functions involving alcohol are not allowed. Such functions will be immediately closed down without a refund of your deposit. Initial _____
5. In-Out privileges: For banquets and receptions, in-out privileges are allowed. However, if patrons are found to be drinking alcohol outside (i.e. car in parking lot) and re-entering the function, the function will be terminated without a refund. Initial _____
6. Rental groups will be expected to reimburse the county for any of the following: a. Lost or damaged equipment b. Any area requiring additional cleaning c. Parking lot clean up d. Vandalism Initial _____
7. The person named on the contract is responsible for monitoring the event for any guests that appear intoxicated, disorderly, or disrespectful to staff and the property, and any other acts deemed inappropriate or offensive by the building staff. Initial _____
8. Pierce County Parks & Recreation Staff has the authority to have an individual(s), at the event, removed if their actions are deemed inappropriate or they are overly intoxicated. Failure by the person responsible -contract holder named above - to immediately remove individuals from the function will be cause to shut down the entire event, and forfeiting their deposit. In the event this action is taken, the Pierce County Sheriff's Department will be contacted. Initial _____
9. ANY FUNCTION THAT IS FOUND WITH UNAUTHORIZED ALCOHOL WILL BE STOPPED IMMEDIATELY AND FORFEIT THEIR DEPOSIT. Initial _____

THE SERVER MUST HAVE THE FOLLOWING:

1. MANDATORY ALCOHOL SERVER TRAINING (MAST)

The 1995 Legislature passed a law requiring Mandatory Alcohol Server Training (MAST) for managers, bartenders and anyone who serves alcohol on-premises. **If you serve alcohol or supervise the sale of alcohol for on-premises consumption in the State of Washington, you will need a MAST permit.**

Class 12 Mixologist Permit - For managers, bartenders and anyone who draws alcohol from a tap, mixes drinks with alcohol and is at least 21 years old. Class 12 permit holders are also authorized to perform duties included in the Class 13 permit. Every licensed business where spirits, beer and wine are consumed on the premises must have at least one Class 12 permit holder on duty.
