EMS discrepancy explanation

We believe that an envelope containing two ballots was not identified on our opening floor.

Batch was scanned as is, with the additional ballot included.

Process - Our batch tracking system begins with our mail sorter. It produces opening batches of valid ballots. The next process is for an election worker to hand count the envelopes to confirm the batch matches the sorter count. They then remove the secrecy envelopes, shuffle them, and proceed to open and visually scan all the ballots. Next they count the number of ballots. Lastly the batch is transferred to tabulation and the scanner makes a final count.

Results of Research - This batch was stopped at tabulation, as it contained 251 ballots instead of the recorded 250. Using our batch tracking system as well as reports from our sorter it was determined that one envelope was thicker than the rest of the batch. It measured .062, while a standard ballot packet measures .038. The sorter diverts for review ballot packets that are too thick to catch double ballots. The threshold for diversion is .063. The envelope count was confirmed multiple times as well as the ballot count. It appears that the opener may have pulled two ballots from one envelope and not noticed, then miscounted before transferring the batch to tabulation. Because it was impossible to identify what two ballots were originally in the oversized envelope, we tabulated the batch as-is.
