**R-1: Registered voter at the time of filing and a resident for one year.
(Non-Charter Code City)**

**R-2: Registered voter at the time of filing and a resident of the city for two years preceding the time of filing and a resident of their district for one year immediately preceding filing.
(City of Tacoma)**

R-5: Registered voter at the time of filing, a resident of the County for a period of at least five years preceding the election and reside in the Council District of the position for which they are filing.
