Pierce County Human Services is making available the 2020-2024 Consolidated Plan, 2020 One Year Action Plan, and Substantial Amendment to 2019 One Year Action Plan for public review and comment for 30-days from April 1 through May 6, 2020. **About the 2020 – 2024 Consolidated Plan and 2020 One Year Action Plan**

Human Services is required by the Department of Housing and Urban Development (HUD) to submit a Consolidated Plan every five years which describes community needs, resources, priorities, and proposed activities to be undertaken in Pierce County under HUD programs (Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and Home Investment Partnerships (HOME)). These funding sources are to assist lower-income people, households, and communities throughout unincorporated areas in Pierce County, as well as the Pierce County Consortium Cities and Towns. In addition, Human Services is required to submit to HUD annually, a One Year Action Plan. The 2020 One Year Action Plan details how Pierce County will allocate funds from CDBG, ESG, and HOME to accomplish the priority needs and goals set forth in the 2020-2024 Consolidated Plan. Both documents are due to HUD by May 15, 2020.

**About the Substantial Amendment to the 2019 One Year Action Plan**

The 2019 One Year Action Plan was submitted to HUD and approved on July 3, 2019. This is the second amendment to the 2019 One Year Action Plan. This substantial amendment repurposes 2019 CDBG public facilities funds that were originally awarded to the YWCA/Pierce County Affordable Housing Project in the amount of \$250,000 to the Pierce County Community Development Corporation for business relief loans. In exchange, the YWCA project will receive Pierce County general funds in the amount of \$250,000 to fund their Affordable Housing project.

**Public Comment Period and Public Hearing**
