Ob hlis ntuj hnuv 29th, 2020, Yawm Xeev Laus **INSLEE** tshaj tawm txoj cai tim tsum **PROCLAMATION 20-05**, rau lub sij hawm kub ntov rau txhua lub nroog uas nyob thooob plaws hauv lub Xeev **WASHINGTON**, vim tias muaj tus kab mob **COVID-19** corona uas tau kis rau hauv Tebchaw Meskas thiab los kis rau hauv lub Xeev **WASHINGTON**.

Ib ncuas sij hawm ntawm cai (**MORATORIUM**) txoj kev sau nqe tsev ntawm cov neeg uas yuav raug ncaws tawm tsev thooob plaws hauv xeev **WASHINGTON**, pab txo tib neeg kev noj qab haus huv, kev ua neej ntawm yus lub neej txoj sia, kev nyab xeeb, thiab ntawm tsoom npoj yaig uas yuav raug poob hauj lwm thiab raug txiav sij hawm tawm, los yog them tsis tau nqe tsev yog vim tus kab mob **COVID-19** hauv xeev **WASHINGTON**.

Yog vim (**MORATORIUM**) ib ncuas sij hawm ntawm txoj kev sau nqe tsev ntawm cov neeg uas yuav raug ncaws tawm tsev, (1) pab txos tus nqe ntawm vaj tsev, kev noj haus, (2) yuav tswj hwm tau pej xeeb nyob tsev tsuas yog yuav mus hauj lwm los yog muaj kev lag luam xwb thiaj tawm tau mus, thiab (3) nthuav tawm rau niam txiv pej xeeb kev noj qab haus huv thiab kev nyab xeeb thiab txos kom tau tus kab mob hauv xeev **WASHINGTON**.

Important Facts to Note:

1. **Qhov cai MORATORIUM tsis txhais hais koj yuav tsis tas them nqe tsev. Hauv qab txoj cai MORATORIUM, cov tswv tsev tsis muaj cai nce nqe tsev, tab sis tswv tsev yuav tsum khom nqe rau yus them lwm lub caij los tau. Tswv tsev tsis muaj cai nce nqe them lig hauv qab txoj cai MORATORIUM. Tiam sis tswv tsev tseem muaj lwm txoj ncauj kev muab koj ncaws tawm, xws li yog koj tau tsoo tsev pua los yog tsis muaj kev dawb huv raws tebchaw cov cai.**
2. **Qhov cais PROCLAMATION, ntawm uas Yawm Xeev Laus **INSLEE** tau xyuam, txwv kev pauj kuas zaub ntsuab thiab tawm tsam cov neeg yeev tsev. Thiab kom muaj txoj cai tiv thaiv cov uas yeev tsev nyob.**
